

Chapter 1 Introduction

Referral of the 2015-2016 Budget Estimates

- On 24 June 2015, the Legislative Council resolved that 'the Budget Estimates and related papers for the financial year 2015-2016 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report'. The resolution (hereafter referred to as the Budget Estimates resolution) requires each committee to examine the Budget Estimates for the relevant portfolios and report to the House by 18 December 2015.²
- 1.2 The Budget Estimates resolution further stipulated that the initial hearings will be held in the week commencing 31 August 2015 and the initial round of supplementary hearings be scheduled during the week of 6-9 October 2015.³
