

Chapter 1 Introduction

Referral of the 2017-2018 Budget Estimates

- **1.1** On 21 June 2017, the Legislative Council resolved that 'the Budget Estimates and related papers for the financial year 2017-2018 presenting the amounts to be appropriated from the Consolidated Fund be referred to the Portfolio Committees for inquiry and report'.¹ The resolution (hereafter referred to as the Budget Estimates resolution) requires each committee to examine the Budget Estimates for the relevant portfolios and report to the House by 15 December 2017.²
- **1.2** The Budget Estimates resolution further stipulated that the initial hearings be held from 31 August to 8 September 2017 and the initial round of supplementary hearings be scheduled during the week of 3-6 October 2017.³

Hearings

- **1.3** The committee held four public hearings as follows:
 - Tuesday 5 September 2017 Family and Community Services, Social Housing, Prevention of Domestic Violence and Sexual Assault
 - Tuesday 5 September 2017 Mental Health, Women, Ageing
 - Wednesday 6 September 2017 Health, Medical Research
 - Thursday 7 September 2017 Disability Services, Multiculturalism.
- **1.4** The committee also held supplementary hearings on Thursday 26 October 2017 for the Disability Services portfolio, and on Tuesday 31 October 2017 for the Health portfolio.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary by portfolio of the key issues raised during the hearings.

Family and Community Services, Social Housing, Prevention of Domestic Violence and Sexual Assault

- **2.1** A hearing examining the portfolios of Family and Community Services, Social Housing, Prevention of Domestic Violence and Sexual Assault was held on Tuesday 5 September 2017. The following issues were raised during the committee's examination of these portfolios:
 - Actions following the death of a child in the care of Life Without Barriers
 - Use of temporary hotel accommodation for children in out of home care
 - Women's refuge numbers
 - Supports and behaviour modification programs for domestic violence perpetrators
 - Sale of social housing stock.

Mental Health, Women, Ageing

- **2.2** A hearing examining the portfolios of Mental Health, Women, Ageing was held on Tuesday 5 September 2017. The following issues were raised during the committee's examination of these portfolios:
 - Staffing at Lismore Base and Cumberland mental health facilities
 - Closing the gender pay gap
 - Support for those experiencing mental health impacts arising from the same sex marriage plebiscite
 - Suicide prevention
 - Attracting and retaining older workers in the workplace
 - Impact of recent Fair Work Commission decision regarding penalty rates on female workers.

Health, Medical Research

- **2.3** A hearing examining the portfolios of Health, Medical Research was held on Wednesday 6 September 2017. The following issues were raised during the committee's examination of these portfolios:
 - Paediatric services in New South Wales
 - Initiatives to decrease flu outbreaks

- Avian flu mutations in the poultry industry
- Investigations into the cladding used in hospital construction
- Availability of ambulance services in regional areas of New South Wales.
- **2.4** A supplementary hearing examining the portfolio of Health was held on Tuesday 31 October 2017. The following issues were raised during the committee's examination of this portfolio:
 - Cladding in public hospitals
 - Influenza vaccinations
 - The status of orthopaedic services at South Eastern Regional Hospital (Bega)
 - Downgrade of Nepean Hospital trauma rating
 - E-cigarettes and the legality of cafes with indoor vaping facilities
 - Super station evaluations for NSW paramedics
 - Crib breaks for paramedics and whether they are compulsory

Disability Services, Multiculturalism

- **2.5** A hearing examining the portfolios of Disability Services, Multiculturalism was held on Thursday 7 September 2017. The following issues were raised during the committee's examination of these portfolios:
 - Secondary employment approvals for senior staff of the Department of Family and Community Services
 - NSW Government agency compliance with obligations under the *Disability Inclusion Act* 2014 to complete Disability Inclusion Action Plans
 - Funding for disability advocacy, information and representation services following the transition to the National Disability Insurance Scheme
 - Access to public housing, social housing and group homes for people with disability
 - Rates of reportable incidents in government and non-government facilities for people with disability
 - Education opportunities for students with disability and school inclusion.
- **2.6** A supplementary hearing examining the portfolio of Disability Services was held on Thursday 26 October 2017. The following issues were raised during the committee's examination of this portfolio:
 - Cessation of employment of a senior executive of the Department of Family and Community Services
 - Role of the NSW Government in delivering disability services following the roll-out of the National Disability Insurance Scheme
 - Funding of advocacy services for people with disability

- Inclusion of children with disability in schools
- Productivity Commission projections on National Disability Insurance Scheme participation in New South Wales.
