

# Terms of reference

- 1. That on tabling, the Budget Estimates and related papers for the financial year 2019 2020 presenting the amounts to be appropriated from the Consolidated Fund be referred to the Portfolio Committees for inquiry and report.
- 2. That for the purposes of the Budget Estimates inquiry 2019 2020:
  - (a) initial hearings be scheduled over 12 days from 29 to 30 August, 2 to 6 September and 9 to 13 September 2019, with the examination of portfolios on those days to be specified by further resolution of the House,
  - (b) supplementary hearings be scheduled over five days from 28 October to 1 November 2019, or on such other dates as required, with the examination of portfolios on those days to be determined by resolution of each committee,<sup>1</sup>
  - (c) further hearings be scheduled over 12 days from 2 to 17 March 2020, with the examination of portfolios on those days to be specified by further resolution of the House and the time for giving of evidence by ministers, parliamentary secretaries and officers to be determined by resolution of each committee,<sup>2</sup>
  - (d) each scheduled day for the initial and further rounds<sup>3</sup> of hearings will begin at 9.30 am and conclude by 8.30 pm,<sup>4</sup>
  - (e) the committees must hear evidence in public,
  - (f) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
  - (g) witnesses, including ministers, may not make an opening statement before the committee commences questions,
  - (h) members may lodge supplementary questions with the committee clerk by 5.00 pm within two days, excluding Saturday and Sunday, following a hearing,
  - (i) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members, and
  - (j) committees are to present a final report to the House by 30 June 2020.

- 3. That this House resolve to adopt a revised schedule for future budget estimates inquiries similar to the Senate estimates process comprised of:
  - (a) an initial round of estimates hearings over 12 days on the tabling of the Budget Estimates and related papers,
  - (b) supplementary hearings scheduled over five days in October or November of that year, and
  - (c) further hearings scheduled over 12 days in February or March of the following year.

The terms of reference were referred to the committee by the House on 8 May 2019, and amended on 16 October 2019 and 20 November 2019.<sup>5</sup>

# Chapter 1 Introduction

The Inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The Inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the Inquiry consists of answers provided during public hearings and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

# Referral of the Budget Estimates 2019-2020

- 1.1 The Inquiry into Budget Estimates 2019-2020 ('the Inquiry') was referred to the portfolio committees on 8 May 2019 by the Legislative Council. The budget estimates resolution establishing the Inquiry and that sets out the rules for the Inquiry is reproduced on page iv and v.
- 1.2 The budget estimates resolution this year had significant procedural changes compared to previous years. The amount of time for questioning for each portfolio area was significantly increased, and the duration of the whole inquiry across all the portfolio committees was 12 days, compared to previous years of five. The variations to the conduct of the Inquiry are outlined below.

### Total hearing time for questioning

- 1.3 The resolution authorised the committees to conduct three rounds of hearings: initial, supplementary and further hearings, from 9.30 am to 8.30 pm, to examine all portfolios for each minister.
- 1.4 The total amount of time available for scrutiny was nearly tripled compared to previous estimates inquiries. In the past, only two rounds of hearings (initial and supplementary) were conducted and portfolios under the same minister were examined for under four hours duration. That meant that Ministers and senior public servants could generally face a maximum of eight hours of questioning over two budget estimates hearings. In contrast, under the new resolution Ministers and senior public servants could face potentially up to 33 hours of questioning over three different hearings.
- 1.5 On 16 October 2019, the House amended the resolution to require only initial and further rounds of the hearings to begin at 9.30 am and conclude by 8.30 pm. The committees were therefore able to determine when and how much time was required for supplementary hearings, if any.<sup>7</sup>

#### Witnesses

- 1.6 The resolution required ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure, to appear in the morning session, and only officers giving further evidence during the afternoon session.<sup>8</sup> It is noted that parliamentary secretaries were not required to give evidence to earlier estimates inquiries.
- 1.7 On 20 November 2019, the resolution was further amended so that, for the further hearings, each committee could determine who (ministers, parliamentary secretaries, public servants, or representatives from statutory bodies) they wanted to call and for how long they were to appear within the parameters of 9.30am to 8.30pm.<sup>9</sup>

# Number of hearings

1.8 The Budget Estimates resolution, as amended, stipulated that the initial hearings be held between 29 August and 13 September 2019, supplementary hearings from 28 October to 1 November 2019, and further hearings from 2 to 17 March 2019. 10

# Chapter 2 Issues raised during hearings

This chapter provides a brief summary by portfolio of the key issues raised during the hearings.

# Attorney General and Prevention of Domestic Violence

- A hearing examining the portfolio of Attorney General and Prevention of Domestic Violence was held on Monday 2 September 2019. The following issues were raised during the committee's examination of this portfolio:
  - Deaths of Jacinta Rosa Smith and Mona Lisa Smith
  - Investigation into workplace issues at Victims Services
  - Legal Aid private practitioner rates
  - Coronial inquests and review of coronial process and legislation
  - Victims immediate support and recognition payments
  - Aboriginal Custody Notification Service
  - Funding for Women's Family Law Court Support Service
  - Funding for Women's Domestic Violence Court Assistance
  - Aboriginal family and domestic violence services funding
  - Companion animal protection in family and domestic violence
  - Law Enforcement (Powers and Responsibilities) Act 2002 implementation of amendments
  - Mandatory reporting of child sexual offences
  - Age of criminal responsibility
  - Surveillance device warrants
  - Cross examination of victims by perpetrators
  - Operation and expansion of the Drug Court
  - Discretionary police powers and whether justice outcomes for Aboriginal and Torres Strait Islander peoples are fair and equal
  - The mental health and wellbeing of magistrates and what support is available to them
  - The imposition of efficiency dividends and whether this is limiting the Director Public Prosecutions' ability to pursue prosecutions
  - The Early Appropriate Guilty Pleas Program and whether this reform has achieved its stated aim in reducing court waiting times
  - District Court resourcing and how its workload is being managed with the appointment of 12 new judges since October 2018

- GIPAA requests and the Government's policy of not mandatorily requiring its departments to receive these via electronic submission
- The Men's Behaviour Change Program and its performance in helping reduce domestic violence reoffending
- The number of dedicated crisis beds that exist for women experiencing domestic and family violence and what other programs are available to help keep women and children safe
- Coordination between the Health and Stronger Communities clusters in seeking to reduce domestic violence rates
- Contract funding uncertainty in the NGO sector and its impact on service outcomes.
- 2.2 A further hearing examining the portfolio of Attorney General and Prevention of Domestic Violence was held on Friday 13 March 2020. The following issues were raised during the committee's examination of this portfolio:
  - Allocation of funding given to Legal Aid and the hourly rates paid to lawyers and whether this is sufficient
  - Preparations within the court system for the COVID-19 pandemic, in particular plans for managing the high volume of cases before the local court
  - Timeframe for allowing historical settlements in child sexual abuse cases to be set aside as per the recommendation of the Royal Commission into Institutional Responses to Child Sexual Abuse
  - Potential reform of section 293 of the *Criminal Procedure Act 1986* and the associated consultation process
  - Funding for domestic violence services and whether allocated funding is sufficient to meet demand
  - Allegation of bail compliance checks being undertaken without court authority under section 30 of the *Bail Act 2013*
  - Facial recognition technology
  - NSW Drug Court
  - Efficiency dividend impacts on the Department
  - Adult re-offending rates.

## **Counter Terrorism and Corrections**

- 2.3 A hearing examining the portfolio of Counter Terrorism and Corrections was held on Monday 9 September 2019. The following issues were raised during the committee's examination of this portfolio:
  - Intensive Correction Orders (ICO) and in particular that relating to the individual charged with the manslaughter of a 12 year old in Hurstville

  - Abdul Rahman incident and any proposed changes to policies for the intensive corrections order regime

- Impact of the recent bushfires on correctional services across the state, including the decision to not evacuate the Lithgow correctional centre
- Management of the coronavirus in correctional centres
- Increase in recidivism rates in prisons
- Vocational education and training programs for inmates in prisons
- Electronic monitoring of serious sex offenders living in the community
- Needle and syringe programs in correctional centres

  - Reasons for the alleged increase in strip searches from 2006 to 2019
  - Improvements to water safety in preparation for summer
  - Workers' compensation entitlements for special constables
  - Staffing reductions of the Firearms Registry and projects undertaken by the registry
  - Use of technology to keep the community safe
  - Effects of budget cuts on front line services provided by Fire and Rescue NSW
  - Operation and staffing of the Bias Crime Unit
  - Police station staffing numbers in remote and regional locations
  - Changes to the police death and disability scheme and eligibility criteria for officers aged above 60
  - Staffing numbers and the performance of the Firearms Registry
  - Compliance with firearm license conditions
  - Effectiveness of diversionary programs for young offenders
  - Police use of spyware and other IT programs during criminal investigations
  - Police strip search statistics and policing techniques used in searching for illicit drugs
  - The regulation of firearm suppressors and eligibility requirements
  - Bullying and harassment in emergency services and the responses of senior management in dealing with any allegations
  - The budget allocation for firefighter protective clothing
  - Counter terrorism policy and the effectiveness of community engagement programs.
- 2.8 A further hearing examining the portfolio of Police and Emergency Services was held on Tuesday 10 March 2020. The following issues were raised during the committee's examination of this portfolio:
  - Circumstances surrounding the Minister's firing of prohibited weapons at the John Morony Correctional Complex rifle range
  - Police investigation of the operation of Corrective Services firing ranges
  - Police investigation of the Minister's involvement in a traffic incident in October 2019
  - The taking of leave by the Minister during the bushfire crisis over the Christmas/New Year period

- Operation and management of the Firearms Registry
- Issues relating to the 2019/2020 bushfire season, including state of emergency declarations, communications between the NSW Rural Fire Service and responsible Ministers, appliance numbers, suitability and schedule for upgrades, operation and decision making of Incident Management teams, the impact of climate change, and mental health impacts on emergency services personnel
- Exemptions from the annual efficiency dividend for NSW Fire & Rescue and NSW Rural Fire Service staffing costs
- The upgrade of Karuah Police Station and other regional police stations
- Police investigation of an alleged forged document relating to City of Sydney travel expenses
- Revision of search warrant numbers
- Search warrant quota policy.

# Sport, Multiculturalism, Seniors and Veterans

- A hearing examining the portfolio of Sport, Multiculturalism, Seniors and Veterans was held on Thursday 12 September 2019. The following issues were raised during the committee's examination of this portfolio:
  - Minister Sidoti's compliance with disclosure of interest and other requirements under the Ministerial Code of Conduct.
  - Relocation of professional sporting teams to alternate stadia during the rebuild of the Sydney Football Stadium and refurbishment of Stadium Australia
  - How relevant agencies work together to respond to instances of Islamophobia and race hate
  - The governance and management of Sydney's stadiums and whether they should be overseen by one body rather than two
  - The consultation process used in developing Multicultural NSW's strategic review 2019 to 2023 and whether sufficient ethnically and linguistically diverse groups have had their input incorporated
  - Children's sporting participation rates from lower socioeconomic backgrounds
  - Redemption rates for the Active Kids voucher program and what the government has spent on the program to date
  - The government's approach to managing an ageing population and the adequacy of its response to things such as increasing elder abuse rates and more older women being homeless
  - The government's response to the recommendations of the Productivity Commission's A Better Way to Support Veterans report

- Where the government is up to in delivering local sporting facilities that were promised at the recent election
- Whether the NRL grand final will remain in Sydney beyond 2020.
- 2.10 A further hearing examining the portfolio of Sport, Multiculturalism, Seniors and Veterans was held on Friday 6 March 2020. The following issues were raised during the committee's examination of this portfolio:
  - Minister Lee's capacity to manage his substantive portfolio responsibilities and his appointment as Acting Minister of Sport, Multiculturalism, Seniors and Veterans
  - The use of a State Government sports grant to Penrith Panthers made prior to the 2015 election to fund conference facilities and the role of the Office of Sport
  - Regional and Greater Sydney sports grants in the lead up to the 2019 State election and the decision making process
  - The cost of the Sydney Football Stadium rebuild and the absence of a LED curtain for the upper tier of the stadium
  - The timing and consultation in relation to the rebuild of the Sydney speedway
  - Homelessness amongst older women in New South Wales
  - Protecting seniors from coronavirus
  - The decline in diversity in the public service
  - Disruption costs attributable to the demolition and rebuilding of the Sydney Football Stadium at Moore Park in the context that the project deadline has been extended
  - Reports that the tenants of the Sydney Football Stadium were of the opinion that the new facility would include a LED curtain and the process that led to this not happening
  - What contingency plans are in place for crowd management at major sporting events during the COVID-19 pandemic
  - Suicide rates of veterans and the effectiveness of the measures that are in place to minimise this
  - The process through which funding allocations have been granted through the Regional Sports Infrastructure Fund
  - The role of Multicultural NSW in helping minimise racist attacks on ethnic people during the COVID-19 pandemic
  - Take up rates of the cash vouchers provided by the Active Kids program and where unspent money is being reallocated.
