

Terms of reference

- 1. That on tabling, the Budget Estimates and related papers for the financial year 2019 2020 presenting the amounts to be appropriated from the Consolidated Fund be referred to the Portfolio Committees for inquiry and report.
- 2. That for the purposes of the Budget Estimates inquiry 2019 2020:
 - (a) initial hearings be scheduled over 12 days from 29 to 30 August, 2 to 6 September and 9 to 13 September 2019, with the examination of portfolios on those days to be specified by further resolution of the House,
 - (b) supplementary hearings be scheduled over five days from 28 October to 1 November 2019, or on such other dates as required, with the examination of portfolios on those days to be determined by resolution of each committee,¹
 - (c) further hearings be scheduled over 12 days from 2 to 17 March 2020, with the examination of portfolios on those days to be specified by further resolution of the House and the time for giving of evidence by ministers, parliamentary secretaries and officers to be determined by resolution of each committee,²
 - (d) each scheduled day for the initial and further rounds³ of hearings will begin at 9.30 am and conclude by 8.30 pm,⁴
 - (e) the committees must hear evidence in public,
 - (f) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (g) witnesses, including ministers, may not make an opening statement before the committee commences questions,
 - (h) members may lodge supplementary questions with the committee clerk by 5.00 pm within two days, excluding Saturday and Sunday, following a hearing,
 - (i) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members, and
 - (j) committees are to present a final report to the House by 30 June 2020.

- 3. That this House resolve to adopt a revised schedule for future budget estimates inquiries similar to the Senate estimates process comprised of:
 - (a) an initial round of estimates hearings over 12 days on the tabling of the Budget Estimates and related papers,
 - (b) supplementary hearings scheduled over five days in October or November of that year, and
 - (c) further hearings scheduled over 12 days in February or March of the following year.

The terms of reference were referred to the committee by the House on 8 May 2019, and amended on 16 October 2019 and 20 November 2019.⁵

Chapter 1 Introduction

The Inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The Inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the Inquiry consists of answers provided during public hearings and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Referral of the Budget Estimates 2019-2020

- 1.1 The Inquiry into Budget Estimates 2019-2020 ('the Inquiry') was referred to the portfolio committees on 8 May 2019 by the Legislative Council. The budget estimates resolution establishing the Inquiry and that sets out the rules for the Inquiry is reproduced on page iv and v.
- 1.2 The budget estimates resolution this year had significant procedural changes compared to previous years. The amount of time for questioning for each portfolio area was significantly increased, and the duration of the whole inquiry across all the portfolio committees was 12 days, compared to previous years of five. The variations to the conduct of the Inquiry are outlined below.

Total hearing time for questioning

- 1.3 The resolution authorised the committees to conduct three rounds of hearings: initial, supplementary and further hearings, from 9.30 am to 8.30 pm, to examine all portfolios for each minister.
- 1.4 The total amount of time available for scrutiny was nearly tripled compared to previous estimates inquiries. In the past, only two rounds of hearings (initial and supplementary) were conducted and portfolios under the same minister were examined for under four hours duration. That meant that Ministers and senior public servants could generally face a maximum of eight hours of questioning over two budget estimates hearings. In contrast, under the new resolution Ministers and senior public servants could face potentially up to 33 hours of questioning over three different hearings.
- 1.5 On 16 October 2019, the House amended the resolution to require only initial and further rounds of the hearings to begin at 9.30 am and conclude by 8.30 pm. The committees were therefore able to determine when and how much time was required for supplementary hearings, if any.⁷

Witnesses

- 1.6 The resolution required ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure, to appear in the morning session, and only officers giving further evidence during the afternoon session.⁸ It is noted that parliamentary secretaries were not required to give evidence to earlier estimates inquiries.
- On 20 November 2019, the resolution was further amended so that, for the further hearings, each committee could determine who (ministers, parliamentary secretaries, public servants, or representatives from statutory bodies) they wanted to call and for how long they were to appear within the parameters of 9.30am to 8.30pm.⁹

Number of hearings

1.8 The Budget Estimates resolution, as amended, stipulated that the initial hearings be held between 29 August and 13 September 2019, supplementary hearings from 28 October to 1 November 2019, and further hearings from 2 to 17 March 2019.¹⁰

Hearings

- 1.9 The committee held 9 public hearings as follows:
 - Monday 2 September 2019 Local Government
 - Wednesday 11 September 2019 Planning and Public Spaces
 - Friday 13 September 2019 Energy and Environment
 - Thursday 31 October 2019 Planning and Public Spaces (supplementary hearing)
 - Thursday 31 October 2019 Local Government (supplementary hearing)
 - Thursday 31 October 2019 Energy and Environment (supplementary hearing)
 - Wednesday 4 March 2020 Local Government (further hearing)
 - Friday 6 March 2020 Energy and Environment (further hearing)
 - Friday 13 March 2020 Planning and Public Spaces (further hearing).

Order for the production of papers relating to the Liddell Taskforce

1.11 During the course of the Inquiry, the committee made several requests to the Minister for Energy and Environment, the Hon Matt Kean MP, to produce documents relating to the Liddell Taskforce. The Minister refused these requests, leading the committee to order the documents under standing order 208, which ultimately was not complied with. This section of the report provides an insight into the mechanism used by committees to request State papers and the background to this request made by the committee.

Committee's power to order for the production of state papers

- 1.12 The Legislative Council has the inherent power under the common law principle of necessity to order the production of State papers. The existence of this power was affirmed by the courts in the *Egan* decisions of the late 1990s.¹¹
- 1.13 Committees, appointed by and an extension of the House, also have the delegated power to order the production of State papers. In 2018, as part of its Inquiry into Budget Estimates 2018-2019, the Legislative Council's Portfolio Committee No. 4 Legal Affairs was provided with an advice of the Solicitor General affirming that a parliamentary committee has the power to order the production of State papers. In the advice, the Solicitor General stated:
 - ...that it is more likely than not, in my view, that, if this question of the powers of a parliamentary Committee were to be the subject of a decision of a court, a finding would be made that a Committee of the NSW Parliament has the power to call for a witness to attend and give evidence, including by the production of a document, subject to claims of privilege, such as public interest immunity and legal professional privilege, that may be made by a witness.¹²
- 1.14 In the Legislative Council, the powers of a committee to order the production of State papers is regulated by standing order 208(c), which provides:

208 Powers

A committee has power:

. . .

- (c) to send for and examine persons, papers, records and things, ¹³
- 1.15 On 8 May 2019, at the commencement of the 57th Parliament, the Legislative Council adopted a sessional order establishing procedures for committees to order the production of State papers under standing order 208(c). Under this framework:

- The terms of the order must specify the inquiry to which the order relates and the date by which the documents are to be returned.
- The order is to be communicated by the Clerk of the Parliaments to the Director General
 of the Department of Premier and Cabinet. (The department coordinates returns to order
 on behalf of the government).
- A summary of the terms of the order is to be reported to the House by the President on the next sitting day.
- The return to order is to be lodged with the Clerk and made available to all members of the House.
- The return is to include an indexed list of all documents returned, providing the date of creation of the document, the author of the document and a description of the document.
- Privilege may be claimed over a document or documents in a return, in which case a separate index is to be prepared with reasons for the claim of privilege.
- A member of the committee may, by communication in writing to the Clerk, dispute the validity of a claim of privilege. On receipt of such communication, the Clerk is authorised to release the document or documents to an Independent Legal Arbiter for evaluation and report as to the validity of the claim.
- On completion, the report of the Independent Legal Arbiter is to be made available to members of the committee only. It may be published by order of the committee.
- The committee may authorise the publication of any document or documents received, subject to any process for evaluation of claims of privilege as outlined above.
- 1.16 These arrangements for the production of State papers to committees closely mirror the arrangements for the production of State papers to the House under standing order 52.

The order for papers relating to the Liddell Power Station

- 1.17 During the further hearing into the Energy and Environment portfolio on 6 March 2020, members of the committee raised concerns about public accessibility to a report relating to the Liddell Taskforce (the Taskforce). Members requested the Minister for Energy and Environment, the Hon Matt Kean MP, to provide a copy of the report (in either finalised or draft form). The Minister declined the request claiming that the report will be published in due course by the Taskforce.
- 1.18 The Liddell Taskforce was set up jointly by the Commonwealth and New South Wales Governments to assess the viability and reliability of the Liddell Power Station. Minister Kean informed the committee that the Taskforce's final report will assist the government in determining the future of the power station, the result of which will have associated impacts on the affordability and reliability of electricity supply and household bills in New South Wales, and the safety of workers at the power station.¹⁴

- 1.19 After Minister Kean's appearance at the hearing held on 6 March 2020, the Committee wrote to the Minister on two separate occasions, on 10 and 16 March 2020, to request a copy of the draft of the Liddell Taskforce report and advice provided to the Liddell Taskforce by the Australian Energy Market Operator.¹⁵
- 1.20 In the first instance, Minister Kean declined the request, noting that all related documents will be made public once the Government receives the final report of the Taskforce. ¹⁶ In the second instance, Minister Kean sought the committee's assurance that if he was to produce the requested documents, the committee would afford the same level of protection to them as that afforded to documents produced under standing order 52. ¹⁷ In response, the committee determined that the most appropriate way to satisfy the Minister's request was to make an order for the production of the documents under standing order 208. Pursuant to the sessional order adopted by the House on 8 May 2019, correspondence was subsequently sent to the Secretary of the Department of Premier and Cabinet to this effect.
- 1.21 On 1 April 2020, Mr Tim Reardon, Secretary of the Department of Premier and Cabinet, wrote to the Clerk, declining to produce the documents, citing commercial sensitivities. In the correspondence, Mr Reardon also questioned the committee's power to order the production of documents but indicated that the Department would comply with an order made by the House under standing order 52. A copy of this correspondence is at Appendix 1. On 24 March 2020, Mr Justin Field MLC gave a notice of motion in the House for an order for the production of documents relating to the Liddell Taskforce.
- 1.22 The committee expresses its strong dissatisfaction at the response of Mr Reardon in this matter, and asserts its view, as previously expressed by the Solicitor General, that committees of the Legislative Council have the power to order the production of State papers. Although the committee did not persue this matter on this occasion Mr Field instead pursuing the matter through the House should such a matter arise again, the committee retains the right to report the matter to the House by way of special report to enable the House to take further action.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Energy and Environment

- A hearing examining the portfolio of Energy and Environment was held on Friday 13 September 2019. The following issues were raised during the committee's examination of this portfolio:

 - Climate Change Fund spending and pollution reduction targets

 - Grant of licence to harm to Albury Golf Club, permitting destruction of corellas and wood ducks
 - Lendlease development at Figtree Hill

 - Staffing of Rural Fire Service, including numbers and whether it should remain voluntary
 - Effectiveness of preparation for bushfire season, including hazard reduction
 - Impact of efficiency dividend savings across the department
 - Closure of the Liddell Power Station
 - Implementation of recommendations regarding coal seam gas by the Chief Scientist and Legislative Council Portfolio Committee No. 4 Industry
 - Treatment of injured wildlife after the bushfire season
 - Role of the Minister in providing concurrence for Water Resource Plans
 - Plans to clean-up hazardous waste following the bushfire season
 - Impact of animal agriculture on climate change.

Local Government

I refer to the resolution of the Portfolio Committee No. 7 – Planning and Environment made on 19 March 2020 as part of its inquiry into Budget Estimates 2019-2020, and your correspondence of that date, concerning the Liddell Taskforce report and related papers.

I am advised that the documents contain information some of which is inappropriate to be provided voluntarily as disclosure of this information would prejudice the commercial interests of third parties and/or the State and is subject to privilege. For example, I am advised that the documents contain significant internal financial information of corporate entities and information which may impact the position of corporate entities in the markets in which they operate.

While the High Court has held that the Legislative Council has the power to compel the Executive Government to produce State papers, it is arguable that it is not 'necessary' to give such a power to a Committee. The extent of this power is therefore uncertain and may be challenged where necessary.

Given this uncertainty, it would only be appropriate for these documents to be provided pursuant to a formal order made by the Legislative Council under Standing Order 52. I note that on 24 March 2020, Mr Justin Field, MLC gave notice of a motion under Standing Order 52 for the production of the Liddell Taskforce report and related papers.
