

Conduct of inquiry

The terms of reference for the inquiry were referred to the committee by the Legislative Council on 10 November 2020.

The committee received one submission.

Inquiry related documents are available on the committee's website.

Chapter 1 Overview

- 1.1 The Drug Supply Prohibition Order Pilot Scheme Bill 2020 was introduced to the Legislative Council by the Hon Scott Farlow, on behalf of the Hon. Damien Tudehope, on 22 October 2020.
- 1.2 The object of the bill, as set out in its explanatory note, is as follows:

[T]o establish a pilot scheme for drug supply prohibition orders in 4 pilot scheme areas. During the pilot scheme, a police officer will be able to seek the making of a drug supply prohibition order against a person who is over 18 years of age and has been convicted of a serious drug offence. The order, if made, will permit a police officer to stop, detain and search the person and search certain vehicles, vessels, aircraft or premises without the requirement for a warrant. These powers are only able to be exercised in a pilot scheme area.²

- 1.3 The bill was referred to the committee for inquiry and report on recommendation of the Selection of Bills Committee on Tuesday 10 November 2020. The terms of reference for the inquiry stated that the committee report consist of the hearing transcript only. The referral stipulated a reporting date of 17 November 2020, giving the committee 7 days to conduct its inquiry.
- 1.4 When considering the conduct of the inquiry, the committee determined that it was unable to hold a hearing in the relevant timeframe. This was in part due to the unavailability of committee members, as other committee hearings were taking place on Friday 13 November and Monday 16 November. Additionally, there was limited capacity of Hansard to deliver a transcript in the timeframe, due to the other committee hearings and the sittings of the House.
- 1.5 The committee received one submission from the Law Society of NSW on 12 November 2020. However, in the time available, members were unable to consider the merits of the arguments made by the Law Society in relation to the bill.
- 1.6 The committee returns the bill to the House for its consideration.
