

- 3. That for the purposes of the Budget Estimates inquiry 2021-2022:
 - (a) for each scheduled day of the initial and further rounds of hearings:
 - (i) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 12.30 pm, and from 2.00 pm to 5.45 pm, with an additional 15 minutes reserved for government questions for each of the morning and afternoon sessions,
 - (ii) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm,
 - (b) the committees must hear evidence in public,
 - (c) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (d) witnesses, including ministers, may not make an opening statement before the committee commences questions,
 - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
 - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- 4. That the committees present a final report to the House by 30 June 2022.

Chapter 1 Introduction

The Inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The Inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the Inquiry consists of answers provided during public hearings and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2021-2022

- 1.1 On 11 November 2020 the House resolved that for the purposes of the Budget Estimates inquiry 2021-2022, initial hearings be scheduled over 12 days from 16 August to 20 August 2021, 23 August to 27 August 2021, and 30 to 31 August 2021, and that supplementary hearings be scheduled over five days from 25 October to 29 October 2021.²
- **1.2** The Budget Estimates resolution and schedule was subsequently agreed to by the House on 23 June 2021, referring the Budget Estimates and related papers for 2021-2022 to the Portfolio Committees for inquiry and report.² The budget estimates resolution establishing the Inquiry, which sets out the rules for the Inquiry, is reproduced on pages iv and v.
- **1.3** However, upon nearing the commencement of the initial hearings, the impact of the Delta variant of the Covid-19 virus was being felt through the community, and members of the Legislative Council agreed to defer the initial round of hearings and replace it with fully virtual hearings for eight key portfolio areas. These were: Premier, Treasury, Health, Customer Service and Digital, Education and Early Childhood Learning, Regional NSW, Industry and Trade, Police, and Transport and Roads. The House subsequently retrospectively resolved these arrangements on Tuesday 12 October 2021.³ On the same day, the House also resolved to hold supplementary hearings over 9 days commencing 26 October 2021.⁴
- 1.4 In November 2021, the House resolved that for the purposes of the Budget Estimates inquiry 2021-2022 additional hearings be scheduled over 12 days from 28 February to 4 March 2022, 7 March to 11 March 2022, and 14 March to 15 March 2022.⁵ The House subsequently resolved to hold the hearings over 13 days, commencing 28 February.⁶ Due to significant flooding events affecting northern New South Wales occurring during this time, three hearings Deputy Premier, Regional NSW and Police, Premier, and Emergency Services and Resilience were postponed. On 29 March 2022 the House resolved new hearing dates for these portfolios, and

also authorised each of the Portfolio Committees to hold further additional Budget Estimate hearings up to 30 May 2022.⁷

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Health

- **2.1** A hearing examining the portfolio of Health was held on Monday 23 August 2021. The following issues were raised during the committee's examination of this portfolio:
 - Various issues associated with the Government's response to the COVID-19 pandemic, including:
 - virus transmission among children, including provision for attendance in schools and childcare centres
 - vaccination of children
 - benchmarks for loosening restrictions
 - virus transmission in outdoor settings and closure of some outdoor recreation sites (such as tennis courts) and continuation of greyhound and horse racing events in regional New South Wales
 - public communications around transmission mechanisms and protective measures
 - management of COVID-19 testing and cases in Dubbo, Bathurst, Wilcannia and small communities in western New South Wales
 - vaccination and personal protective equipment for healthcare workers
 - process for the determination of differing levels of restrictions in different local government areas
 - operation of mass vaccination centres
 - contact tracing operations
 - intensive care unit capacity and occupation levels
 - Proposed facilities for the new Rouse Hill Hospital.
- **2.2** A hearing examining the portfolio of Health was held on Thursday 10 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - NSW Health response to floods in Northern NSW
 - Disease outbreaks, including gastroenteritis in flood regions
 - Funding of support services for sexual assault victim-survivors
 - Current COVID-19 numbers in NSW
 - Impact and occurrence of new COVID-19 variants
 - NSW Health response to climate change, and the existence of any policy responses to these impacts
 - NSW Health services in rural, regional and remote NSW
 - Incidents of Japanese Encephalitis in NSW
 - Ambulance blockages in hospitals in NSW

- Testing and medical research on animals
- Nurse patient ratios in Intensive Care Units, and other wards.

Health and Medical Research

- **2.3** A hearing examining the portfolio of Health and Medical Research was held on Thursday 4 November 2021. The following issues were raised during the committee's examination of this portfolio:
 - Health response to COVID-19, including current vaccination rates, plans for booster shots and utility of rapid antigen testing
 - Impact of COVID-19 response on other services, such as breast cancer screening, elective surgery and health promotion
 - Regulation of the cosmetic surgery industry
 - Health services in rural and regional areas, particularly staffing issues at rural, regional and remote hospitals
 - NSW Health response to possibility of cruise industry re-starting
 - Ambulance response times, and distribution of ambulances and paramedics across the state
 - Decision making process for health infrastructure spending
 - Women's access to health care

Mental Health, Regional Youth and Women

- 2.4 A hearing examining the portfolio of Mental Health, Regional Youth and Women was held on Friday 5 November 2021. The following issues were raised during the committee's examination of this portfolio:
 - Impact of COVID-19 on women
 - Suicide prevention programs
 - Mental health intensive care units
 - Mental health programs for veterinarians
 - Suicide prevention programs targeting specific communities including LGBTQI people, older people, people who have previously attempted suicide in regional communities, men, young people and people with disabilities
 - The number of suicides in rural, regional and remote NSW compared with Sydney
 - Mental health impacts of lockdown on children.

Women, Regional Health, Mental Health

- **2.5** A hearing examining the portfolio of Women, Regional Health, Mental Health was held on Thursday 3 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - The impact of the recent northern NSW floods on the regional health system and NSW Health's response to the water emergency, including:
 - evacuation of the local hospitals at Ballina and Lismore,
 - mental health support for the communities impacted,
 - mosquito-borne diseases, water contamination and sewerage overflow
 - Questions regarding the responsibilities of the new Regional Health portfolio, and its differentiation from the Health portfolio.
 - Third review of the 'Rural Health Plan: Towards 2021' and whether Portfolio Committee No 2 inquiry into rural, regional and remote health services will be taken into consideration as part of the review
 - Update on suicide prevention strategies, particularly for young people
 - Lack of access to healthcare services in rural, regional and remote New South Wales
 - Rates of seclusion and restraint in mental health facilities across New South Wales
 - Women's health, mental health, workforce participation and equal opportunity, including:
 - lack of maternity and neonatal services in rural, regional and remote New South Wales and NSW Health's response
 - strategies to support women in the workplace suffering with endometriosis
 - work opportunities for women in rural and regional communities
 - women in leadership roles in the public service as well as the number of FTE staff at Women NSW
 - government initiatives to address high rates of women experiencing homelessness.
