

- 3. That for the purposes of the Budget Estimates inquiry 2021-2022:
 - (a) for each scheduled day of the initial and further rounds of hearings:
 - (i) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 12.30 pm, and from 2.00 pm to 5.45 pm, with an additional 15 minutes reserved for government questions for each of the morning and afternoon sessions,
 - (ii) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm,
 - (b) the committees must hear evidence in public,
 - (c) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (d) witnesses, including ministers, may not make an opening statement before the committee commences questions,
 - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
 - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- 4. That the committees present a final report to the House by 30 June 2022.

The key evidence gathering mechanism of this Inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>Inquiry's webpage</u>.

On behalf of the committee, I would like to thank the ministers and their officers who assisted the committee during this important inquiry. I am grateful to my fellow committee members and the secretariat staff for their contributions to the inquiry process.

Chapter 1 Introduction

The Inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The Inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the Inquiry consists of answers provided during public hearings and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2021-2022

- 1.1 On 11 November 2020 the House resolved that for the purposes of the Budget Estimates inquiry 2021-2022, initial hearings be scheduled over 12 days from 16 August to 20 August 2021, 23 August to 27 August 2021, and 30 to 31 August 2021, and that supplementary hearings be scheduled over five days from 25 October to 29 October 2021.²
- **1.2** The Budget Estimates resolution and schedule was subsequently agreed to by the House on 23 June 2021, referring the Budget Estimates and related papers for 2021-2022 to the Portfolio Committees for inquiry and report.² The budget estimates resolution establishing the Inquiry, which sets out the rules for the Inquiry, is reproduced on pages iv and v.
- **1.3** However, upon nearing the commencement of the initial hearings, the impact of the Delta variant of the Covid 19 virus was being felt through the community, and members of the Legislative Council agreed to defer the initial round of hearings and replace it with fully virtual hearings for eight key portfolio areas. These were: Premier, Treasury, Health, Customer Service and Digital, Education and Early Childhood Learning, Regional NSW, Industry and Trade, Police, and Transport and Roads. The House subsequently retrospectively resolved these arrangements on Tuesday 12 October 2021.³ On the same day, the House also resolved to hold supplementary hearings over 9 days commencing 26 October 2021.⁴
- 1.4 In November 2021, the House resolved that for the purposes of the Budget Estimates inquiry 2021-2022 additional hearings be scheduled over 12 days from 28 February to 4 March 2022, 7 March to 11 March 2022, and 14 March to 15 March 2022.⁵ The House subsequently resolved to hold the hearings over 13 days, commencing 28 February.⁶ Due to significant flooding events affecting northern New South Wales occurring during this time, three hearings Deputy Premier, Regional NSW and Police, Premier, and Emergency Services and Resilience were postponed. On 29 March 2022 the House resolved new hearing dates for these portfolios, and

also authorised each of the Portfolio Committees to hold further additional budget estimate hearings up to 30 May $2022.^7$

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Customer Service and Digital

- **2.1** A hearing examining the portfolio of Customer Service and Digital was held on Wednesday 25 August 2021. The following issues were raised during the committee's examination of this portfolio:
 - Service NSW COVID-19 business assistance grants
 - Functions of Service NSW centres during COVID-19
 - Protections for workers who have adverse reactions to vaccine
 - Relocation of poker machine licences from regional areas to The Star casino
 - Cybersecurity breaches experienced by Service NSW and the Department of Customer Service more generally
 - NSW Audit Office report on managing cyber risks
 - Implementation and progress of recommendations made by Portfolio Committee No.1 on cybersecurity
 - Remediation process for underpayment of injured workers by icare.
- **2.2** A hearing examining the portfolio of Customer Service and Digital was held on Wednesday 27 October 2021. The following issues were raised during the committee's examination of this portfolio:
 - Functions of the State Insurance Regulatory Authority
 - Service NSW data, including the number of check-ins per day
 - Available data in the Service NSW app, and the use of push notifications to inform people they have visited a venue where a COVID-positive case has been determined
 - Operation of suppressed ABNs
 - Gambling harm reduction strategies
 - Delayed licence tests at Service NSW
 - Uptake of outdoor dining in Sydney CBD and other areas of NSW
 - Money laundering in casinos.

Transport and Roads

- **2.3** A hearing examining the portfolio of Transport and Roads was held on Friday 3 September 2021. The following issues were raised during the committee's examination of this portfolio:
 - COVID-19 exposure, rapid antigen testing, and vaccination for transport workers
 - cancellation and reduction of public transport services
 - cost, efficiency, capacity, performance and testing of new Emerald Class ferries
 - the reinstatement of a ferry service at La Perouse and Kurnell, including the construction of new wharves
 - disparities between northern and southern parts of the State's mobile speed camera program
 - the proposed Yarra Bay cruise ship terminal
 - WestConnex construction impacts
 - plans for the electrification of ferries
 - administration of the Transport Asset Holding Entity
 - proposed changes to life jacket requirements on boats
 - a proposed road-user charge for electric vehicles
 - proposed property acquisitions associated with the Western Harbour Tunnel, WestConnex, Sydney Metro and Western Sydney Airport projects
 - cost, network upgrade progress, safety and industrial action associated with the New Intercity Fleet trains
 - budgetary allocations for koala underpasses associated with road infrastructure projects in south-west Sydney.
- **2.4** A hearing examining the portfolio of Transport and Roads was held on Tuesday 2 November 2021. The following issues were raised during the committee's examination of this portfolio:
 - Cracking discovered on Inner West trams and the action the NSW Government has taken to fix this
 - Noise impact of the WestConnex project and what is being used as mitigation measures, as well as contracts for mitigation measures, including gag provisions to prevent residents talking to the media
 - Reforms to the point to point industry, specifically the cancelation of taxi licences.
 - Northern beaches tunnel project, costs and the benefits
 - Toll road contracts across Sydney and how much drivers will be paying between now and 2060.
 - Transitioning buses to electric and hydrogen fuels and the NSW Government's consultation process, cost, timeframes and business case plan

- Sydney trains transitioning to net zero emissions
- Conditions promised surrounding the WestConnex project and high speed buses on that road
- Parramatta Light Rail and delivering stage two of the project
- Safety of cyclists on roads, including driver awareness on safety and projects on cycling infrastructure
- Audit Office of NSW October 2021 performance review on rail freight and greater Sydney and the NSW Government's response to the findings and recommendations of this report
- Acquisition of land for transport projects and instances where non-disclosure agreements are required around the cost of acquisition
- Rail property assets held by the Transport Asset Holding Entity
- Disability standards on New South Wales public transport
- Yarra Bay wharf development and concerns they will be used as a cruise terminal
- Transport for NSW departmental re-structure
- Investigations on how Transport for NSW's data was accessed and information distributed to the dark web.

Regional Transport and Roads

- **2.5** A hearing examining the portfolio of Regional Transport and Roads was held on Tuesday 26 October 2021. The following issues were raised during the committee's examination of this portfolio:
 - The cluster budget for Transport, including public transport and road related expense allocations
 - The regional road reclassification program and the inclusion of roads located in Parramatta, Blacktown and Liverpool
 - The transfer of \$80.3 million from the Fixing Country Roads program to the Restart NSW Fund
 - Updates regarding the status and expenditure of the Dunns Creek Road land purchase, the Brown Mountain upgrade and the Dawson Street Bruxner Highway upgrade
 - Delays experienced by Narrabri Shire Council in receiving funds from the Natural Disaster Fund
 - Inconsistencies in mobile speed camera operation and Acusensus' fulfilment of their contractual requirements
 - UGL's country regional network contract and resultant job losses
 - Regional rail line feasibility studies for Cowra, Gulgong to Maryvale and Kandos to Gulgong

- The proposed extension of the rail trail program in the Glen Innes area
- A status update about the rural and regional seatbelt program
- Non-compliant traffic devices in Tamworth
- Railway level crossing safety
- The South Coast highway bypass program community consultation and the availability of environmental impact assessments
- The consultation process for the Lower Hunter freight corridor
- Review and implementation of successful community consultation models
- The Block and REPAIR grant programs
- Intercity Fleet operations
- Financial assistance for rural taxi drivers
- Inland Rail consultations
- Improvements to truck rest stops
- Bega Valley Shire's request for the Princes and Snowy Mountains highways to be deemed disaster resilient highways.
- **2.6** A hearing examining the portfolio of Regional Transport and Roads was held on Wednesday 16 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - Communications between Transport for NSW and ministers preceding the Sydney rail shutdown on 21 February 2022
 - Response to upcoming industrial action planned for Sydney trains
 - Damage to roads and transport infrastructure in regional New South Wales as a result of recent flooding and storm events
 - Process for community consultation and decision making around routes for the Pacific Highway upgrade
 - Transport for NSW management of the environmental impacts of new road projects, including biodiversity offsets and wildlife corridors
 - Access fees paid for use of transport assets held by TAHE
 - Action taken as a result of the former Minister's directive to clear trees beside state highways after the 2020 bushfires
 - Future plans for rail transport in regional NSW.

Better Regulation and Innovation

- **2.7** A hearing examining the portfolio of Better Regulation and Innovation was held on Wednesday 27 October 2021. The following issues were raised during the committee's examination of this portfolio:
 - Action to ensure real estate agents' compliance with requirements to disclose prohibition orders when advertising properties for sale or rent
 - Project Remediate buildings excluded from the program that continue to present a fire hazard, and progress to date on the program
 - Rehoming of greyhounds, numbers euthanised and numbers catastrophically injured
 - Building Standards Commission revocation of the protection order on the Imperial Towers, Hassall Street Parramatta, with the effect that buyers are locked into purchasing in a defective building
 - Regulator powers and actions in respect of private certifiers
 - NSW Government decision not to sign on to the 2022 National Construction Code minimum accessibility standards
 - Adequacy of compliance with regulation of the engineered stone industry

Metropolitan Roads, Women's Safety and the Prevention of Domestic Violence and Sexual Assault

- **2.8** A hearing examining the portfolio of Metropolitan Roads, Women's Safety and the Prevention of Domestic Violence and Sexual Assault was held on Tuesday 1 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - Directed leave taken by a Transport for NSW Deputy Secretary over the budget estimates period
 - Response of the department and Minister for Metropolitan Roads to the shutdown of Sydney trains on 23 February
 - Funding and effectiveness of domestic and sexual violence services in NSW
 - Government response to the Joint Select Committee on Coercive Control's report.
 - Cost to consumers of road tolls, licence and registration fees
 - Guidelines on placement and signage of mobile speed cameras
 - Progress on planning and procurement of upcoming road infrastructure projects, including the Western Harbour Tunnel.

Transport, Veterans

- **2.9** A hearing examining the portfolio of Transport, Veterans was held on Friday 4 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - Communication between Transport for NSW and Minister Elliott's office prior to the Sydney Trains network shutdown in February 2022
 - Chronology of events leading up to the shutdown of the Sydney Trains network in February 2022
 - Status of NSW Government's ongoing enterprise bargaining negotiations with rail unions
 - Status of the repair of the inner west light rail fleet
 - New Emerald class ferries' operability in heavy swell conditions
 - Effectiveness and safety of driver safety screens installed in public buses and progress of its review
 - Details of NSW Maritime's Boating Now Program
 - Compensation package offered to taxi drivers in New South Wales
 - Toilet facilities available to female workers engaged in Sydney Trains worksites
 - Physical accessibility of the Sydney Trains network and its surrounding infrastructure
 - NSW Government's additional investments in the Transport Asset Holding Entity and the expected rate of return
 - Transport Asset Holding Entity's ongoing negotiations with the NSW Government regarding access fees
 - Details of the proposed new national military cemetery.

Infrastructure, Cities and Active Transport

- **2.10** A hearing examining the portfolio of Infrastructure, Cities and Active Transport was held on Monday 14 March 2022. The following issues were raised during the committee's examination of this portfolio:
 - New roles and responsibilities of the Infrastructure, Cities and Active Transport portfolio
 - Minister's notification and briefing of the train shutdown
 - Impact of flooding to housing and infrastructure, particularly in the Nepean and Hawkesbury region
 - Costs increase to major infrastructure projects (Sydney Gateway, M6 Motorway, WestConnex Rozelle Interchange)
 - Progress of the Northern Beaches Link and Airport link at St Marys
 - Climate change adaptation plans in New South Wales and impact on infrastructure
 - Flooding at the Powerhouse Museum

- Update on e-scooters
- Expansion of the Greater Cities Commission.

Transport

- **2.11** A hearing examining the portfolio of Transport was held on Monday 30 May 2022. The following issues were raised during the committee's examination of this portfolio:
 - Pay negotiations with Transport unions
 - Commencement of Mariyung train fleet
 - Costs of delay of Mariyung train fleet
 - Modifications to the Mariyung train fleet
 - Road tolling review
