

# Terms of reference

The Budget Estimates resolution and schedule was agreed to by the House on 22 June 2022, referring the Budget Estimates and related papers for 2022-2023 to the Portfolio Committees for inquiry and report and is reproduced, as amended on 10 August 2022, as follows<sup>1</sup>:

- (1) That the Budget Estimates and related papers for the financial year 2022-2023 presenting the amounts to be appropriated from the Consolidated Fund be referred to the Portfolio Committees for inquiry and report.
- (2) That, further to the resolution of the House of 16 November 2021 adopting the 2022 sitting calendar, the 2022- 2023 initial budget estimates hearings be scheduled as follows:

- (3) That for the purposes of the 2022-2023 initial budget estimates hearings:
  - (a) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 11.00 am, and from 11.15 am to 12.45 pm, then from 2.00 pm to 3.30 pm, and from 3.45 pm to 5.15 pm, with 15 minutes reserved for Government questions at the end of the morning and afternoon session, if required,
  - (b) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm.
- (4) That, further to the resolution of the House of 16 November 2021 adopting the 2022 sitting calendar, the 2022-2023 supplementary budget estimates hearings be held over five days from 24 October to 28 October 2022.
- (5) That for the purposes of the 2022-2023 initial and supplementary budget estimates hearings:
  - (a) the committees must hear evidence in public,
  - (b) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
  - (c) ministers be invited to appear for the morning sessions only unless requested by committees to appear also for the afternoon session,
  - (d) witnesses, including ministers, may not make an opening statement before a committee commences questions,
  - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
  - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- (6) That the committees present a final report to the House by 23 December 2022.

On 21 September 2022, the Budget Estimates resolution and schedule, as it relates to the Corrections hearing, was varied by the House as follows<sup>2</sup>:

- (1) That this House notes that:
  - (a) on Wednesday 22 June 2022, the House adopted a schedule of initial budget estimates hearings for 2022-2023 over 13 working days from Monday 22 August to Wednesday 7 September 2022, and
  - (b) the following hearing was unable to be conducted as scheduled by Portfolio Committee No. 5 Regional NSW and Stronger Communities due to the unavailability of the Minister:

Day Six:Monday 29 August 2022PC 5Corrections

(2) That in view of the inability of Portfolio Committee No. 5 – Regional NSW and Stronger Communities to conduct this hearing, the committee be authorised to undertake the hearing on a date of its choosing under the same arrangements as originally agreed to by the House on Wednesday 22 June 2022.

According to a resolution of Portfolio Committee No. 5 - Regional NSW and Stronger Communities, the Corrections hearing was rescheduled to Monday, 24 October 2022.

The key evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

## Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

### Budget Estimates 2022-2023

- 1.1 On 16 November 2021 and 22 June 2022, the Legislative Council resolved that hearings for Budget Estimates 2022-2023 be held over 13 days from 22 August to 7 September 2022, and supplementary hearings be scheduled over five days from 24 to 28 October 2022.<sup>3</sup>
- **1.2** The Budget Estimates resolution and schedule was subsequently agreed to by the House on 22 June 2022, referring the Budget Estimates and related papers for the 2022-2023 financial year to the Portfolio Committees for inquiry and report by Friday 23 December 2022.<sup>4</sup>
- **1.3** Following changes to the administration of the government, the hearing schedule was amended by the House on 10 August 2022 to reflect the changed ministerial responsibilities.<sup>5</sup>
- 1.4 On 21 September 2022, the Budget Estimates resolution and schedule was further varied by the House to facilitate the postponement of the initial hearing of Portfolio Committee No. 5 Regional NSW and Stronger Communities into the Corrections portfolio, due to the unavailability of the Minister.<sup>6</sup>
- **1.5** The budget estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv.

## Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

### Treasurer, Energy

- **2.1** A hearing examining the portfolios of Treasurer, Energy was held on Monday 22 August 2022. The following issues were raised during the committee's examination of these portfolios:
  - NSW Government debt
  - Public sector wages
  - First Home Buyer Choice initiative
  - Forestry Corporation
  - Major projects, including power station closures and Dungowan Dam and Pipeline Project
  - Treasury Managed Fund and icare
  - Transport Asset Holding Entity
  - Opportunities to reduce carbon emissions
  - Capital slippage, including Federation Funding Agreements
  - Road tolling processes
  - Various funds and schemes, including Shared Equity Scheme and the Future Economy Fund.

### Finance, Employee Relations

- **2.2** A hearing examining the portfolios of Finance, Employee Relations was held on Friday 26 August 2022. The following issues were raised during the committee's examination of these portfolios:
  - Land tax legislation
  - Wage policy, theft and the gender pay gap
  - Industrial relations awards, agreements and fines
  - Evaluation parameters of productivity proposals
  - The Gig Economy, including employee rights and protections, and non-payment of payroll taxes
  - icare, including the nominal insurers position; payment of bonuses; premium increases; payment delays; the Treasury Managed Fund; under and overpayments of pre-injury average weekly earnings; and return to work rates
  - Dust diseases, including remediation and mandatory health screening.

## Enterprise, Investment and Trade, Sport

- **2.3** A hearing examining the portfolios of Enterprise, Investment and Trade, Sport was held on Thursday 1 September 2022. The following issues were raised during the committee's examination of these portfolios:
  - Status of Investment NSW, including its transition from an agency to a section of the Department of Enterprise, Investment and Trade; resignation of Ms Brown
  - Senior Trade and Investment Commissioners (STICs), including salary and allowances for the London Based Agent-General; STICS Budget allocations
  - Gender equality in sport, including promoting female sport; investing equal money into men's and women's sporting programs; naming grandstands after female athletes
  - Penrith Stadium Project, including cost of project and land acquisition; status of other stadium maintenance and upgrades at Jubilee, Brookvale, and Leichhardt
  - Sydney's night-time economy, including Sydney after dark; trial of special entertainment precinct on Enmore Road
  - CBD Revitalisation Grant Program
  - NSW Institute of Sport, including outcomes for NSW Institute of Sport athletes at Commonwealth Games
  - Western Parkland City Authority, including relocation from Parramatta to Penrith; staffing; budget; Western Sydney City Deal.

## Aboriginal Affairs, Arts, Regional Youth, Tourism

- 2.4 A hearing examining the portfolios of Aboriginal Affairs, Arts, Regional Youth, Tourism was held on Monday 5 September 2022. The following issues were raised during the committee's examination of these portfolios:
  - Proposed Aboriginal Cultural Space at the Museum of Sydney
  - Powerhouse Museum Parramatta, Ultimo and Castle Hill sites
  - Governance structures around Closing the Gap targets and collaboration with Aboriginal Controlled Organisations
  - 'Feel New' NSW tourism campaign
  - Art Gallery of NSW funding arrangements, including the Sydney Modern Project
  - Programs for regional youth, including Holiday Break, Youth Radio, and Regional Gap Year.

## The Legislature

- **2.5** A hearing examining the portfolio of The Legislature was held on Tuesday 6 September 2022. The following issues were raised during the committee's examination of this portfolio:
  - Response to the Broderick report
  - Independent Complaints Officer
  - Review of conditions for members' staff
  - Impact of orders for papers and committee inquiries
  - Work health and safety responsibilities at Parliament House
  - Review of the standing and sessional orders
  - Capital works and air quality at Parliament House.

### Premier, including independent agencies

- 2.6 A hearing examining the portfolio of the Premier was held on Wednesday 7 September 2022. As part of this hearing a panel of independent agencies was examined, comprising the NSW Independent Commission Against Corruption, Office of the Auditor-General, NSW Electoral Commission and NSW Public Service Commission. The following issues were raised during the committee's examination of this portfolio:
  - Senior Trade and Investment Commissioner appointments
  - Resignation of NSW Building Commissioner
  - Powerhouse Museum
  - Auditor-General's Report on Biodiversity Offset Scheme
  - Report of the section 83 inquiry conducted by Mr Graeme Head AO into the employment arrangements for the Senior Investment and Trade Commissioner for the Americas
  - Review by Bruce McClintock SC into former NSW trade minister Stuart Ayres
  - Review of policies and procedures for ministerial offices bullying, harassment, and sexual misconduct, by the Hon. Pru Goward
  - Caretaker requirements and conventions during election period
  - Ministerial drivers
  - Funding for NSW integrity agencies.
