

- (3) That for the purposes of the 2022-2023 initial budget estimates hearings:
 - (a) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 11.00 am, and from 11.15 am to 12.45 pm, then from 2.00 pm to 3.30 pm, and from 3.45 pm to 5.15 pm, with 15 minutes reserved for Government questions at the end of the morning and afternoon session, if required,
 - (b) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm.
- (4) That, further to the resolution of the House of 16 November 2021 adopting the 2022 sitting calendar, the 2022-2023 supplementary budget estimates hearings be held over five days from 24 October to 28 October 2022.
- (5) That for the purposes of the 2022-2023 initial and supplementary budget estimates hearings:
 - (a) the committees must hear evidence in public,
 - (b) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (c) ministers be invited to appear for the morning sessions only unless requested by committees to appear also for the afternoon session,
 - (d) witnesses, including ministers, may not make an opening statement before a committee commences questions,
 - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
 - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- (6) That the committees present a final report to the House by 23 December 2022.

On 21 September 2022, the Budget Estimates resolution and schedule, as it relates to the Corrections hearing, was varied by the House as follows²:

- (1) That this House notes that:
 - (a) on Wednesday 22 June 2022, the House adopted a schedule of initial budget estimates hearings for 2022-2023 over 13 working days from Monday 22 August to Wednesday 7 September 2022, and
 - (b) the following hearing was unable to be conducted as scheduled by Portfolio Committee No. 5 Regional NSW and Stronger Communities due to the unavailability of the Minister:

Day Six: Monday 29 August 2022 PC 5 Corrections

(2) That in view of the inability of Portfolio Committee No. 5 – Regional NSW and Stronger Communities to conduct this hearing, the committee be authorised to undertake the hearing on a date of its choosing under the same arrangements as originally agreed to by the House on Wednesday 22 June 2022.

According to a resolution of Portfolio Committee No. 5 - Regional NSW and Stronger Communities, the Corrections hearing was rescheduled to Monday, 24 October 2022.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2022-2023

- 1.1 On 16 November 2021 and 22 June 2022, the Legislative Council resolved that hearings for Budget Estimates 2022-2023 be held over 13 days from 22 August to 7 September 2022, and supplementary hearings be scheduled over five days from 24 to 28 October 2022.³
- 1.2 The Budget Estimates resolution and schedule was subsequently agreed to by the House on 22 June 2022, referring the Budget Estimates and related papers for the 2022-2023 financial year to the Portfolio Committees for inquiry and report by Friday 23 December 2022.⁴
- 1.3 Following changes to the administration of the government, the hearing schedule was amended by the House on 10 August 2022 to reflect the changed ministerial responsibilities.⁵
- On 21 September 2022, the Budget Estimates resolution and schedule was further varied by the House to facilitate the postponement of the initial hearing of Portfolio Committee No. 5 Regional NSW and Stronger Communities into the Corrections portfolio, due to the unavailability of the Minister.⁶
- 1.5 The budget estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Women, Regional Health, Mental Health

- A hearing examining the portfolios of Women, Regional Health, Mental Health was held on Tuesday 6 September 2022. A number of issues were raised during the committee's examination of these portfolios including:
 - Timing and content of the NSW Rural Health Plan: Towards 2021 Final Progress Review, in light of the committee's inquiry into health outcomes and access to health and hospital services in rural, regional and remote New South Wales
 - The role of the Health Care Complaints Commission and NSW Ombudsman in dealing with complaints regarding health matters in public hospitals
 - Actions in response to the mental health recommendations of the committee's inquiry into health outcomes and access to health and hospital services in rural, regional and remote New South Wales
 - Death at Dubbo Hospital relating to a missed cancer diagnosis
 - Spending identified as benefiting women that is not specifically for women's health services
 - Actions to address suicide in rural and regional areas
 - Priorities of the Regional Health Ministerial Advisory Panel
 - Bullying and intimidatory behavior in NSW Health
 - Memorandum of Understanding between New South Wales and South Australia for the transfer of patients from Broken Hill to Adelaide
 - Eating disorder programs
 - Access to abortion in rural and remote areas
 - Impact of COVID-19 on the mental health system across New South Wales
 - Obstetric violence and birth trauma
 - The Minister's meetings with women's health organisations
 - Quarantining of the previously announced \$743 million boost to palliative care services from any expenditure on the costs of voluntary assisted dying in New South Wales
 - Operationalisation of Voluntary Assisted Dying Act 2021.

Health

- 2.2 A hearing examining the portfolio of Health was held on Wednesday 7 September 2022. A number of issues were raised during the committee's examination of this portfolio including:
 - Update from the committee's inquiry into health outcomes and access to health and hospital services in rural, regional and remote New South Wales with respect to the implementation of recommendations
 - Avoidable deaths in NSW hospitals
 - The inquiry into current and future provision of health services in the South-West Sydney Growth Region
 - COVID-19 updates, including closure of the Sydney Olympic Park vaccination hub;
 COVID-19 reinfection rates; the reduction of the COVID-19 isolation period to five days; long COVID-19 clinics
 - Employment of Extended Care Paramedics
 - Recruitment of additional health workers
 - Minister Hazzard's classification as a casual contact at a function on 22 June 2020
 - Post-COVID clinics
 - Affirmation treatment of children and adolescents who may be or are gender dysphoric
 - Clinical practices at John Hunter Children's Hospital and Maple Leaf House, Newcastle regarding prescribing puberty blockers and cross-sex hormones to children and adolescents who may be or are gender dysphoric
 - Proposed new hospitals in Rouse Hill, the Blue Mountains and Bankstown
 - Hospitalisation rates and vaccines for monkey pox and Japanese encephalitis
 - Alternatives to the use of animals in medical research.

Health - Supplementary hearing

- 2.3 A supplementary hearing examining the portfolio of Health was held on Thursday 27 October 2022. A number of issues were raised during the committee's examination of this portfolio including:
 - Delays of ambulances and in emergency departments
 - Reduction in numbers of beds in public hospitals
 - Medibank cyberattack
 - Hospital upgrades and renovations, including Fairfield Hospital and Rouse Hill Hospital
 - Regulation of cosmetic procedures
 - Effectiveness of vaccines against COVID-19 transmission
 - Minister Hazzard's classification as a casual contact at a function on 22 June 2020

- Update affirmation treatment of children and adolescents who may be or are gender dysphoric
