

- (3) That for the purposes of the 2022-2023 initial budget estimates hearings:
 - (a) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 11.00 am, and from 11.15 am to 12.45 pm, then from 2.00 pm to 3.30 pm, and from 3.45 pm to 5.15 pm, with 15 minutes reserved for Government questions at the end of the morning and afternoon session, if required,
 - (b) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm.
- (4) That, further to the resolution of the House of 16 November 2021 adopting the 2022 sitting calendar, the 2022-2023 supplementary budget estimates hearings be held over five days from 24 October to 28 October 2022.
- (5) That for the purposes of the 2022-2023 initial and supplementary budget estimates hearings:
 - (a) the committees must hear evidence in public,
 - (b) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (c) ministers be invited to appear for the morning sessions only unless requested by committees to appear also for the afternoon session,
 - (d) witnesses, including ministers, may not make an opening statement before a committee commences questions,
 - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
 - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- (6) That the committees present a final report to the House by 23 December 2022.

On 21 September 2022, the Budget Estimates resolution and schedule, as it relates to the Corrections hearing, was varied by the House as follows²:

- (1) That this House notes that:
 - (a) on Wednesday 22 June 2022, the House adopted a schedule of initial budget estimates hearings for 2022-2023 over 13 working days from Monday 22 August to Wednesday 7 September 2022, and
 - (b) the following hearing was unable to be conducted as scheduled by Portfolio Committee No. 5 Regional NSW and Stronger Communities due to the unavailability of the Minister:

Day Six: Monday 29 August 2022 PC 5 Corrections

(2) That in view of the inability of Portfolio Committee No. 5 – Regional NSW and Stronger Communities to conduct this hearing, the committee be authorised to undertake the hearing on a date of its choosing under the same arrangements as originally agreed to by the House on Wednesday 22 June 2022.

According to a resolution of Portfolio Committee No. 5 - Regional NSW and Stronger Communities, the Corrections hearing was rescheduled to Monday, 24 October 2022.

- Planning, Homes.

The key evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2022-2023

- 1.1 On 16 November 2021 and 22 June 2022, the Legislative Council resolved that hearings for Budget Estimates 2022-2023 be held over 13 days from 22 August to 7 September 2022, and supplementary hearings be scheduled over five days from 24 to 28 October 2022.³
- 1.2 The Budget Estimates resolution and schedule was subsequently agreed to by the House on 22 June 2022, referring the Budget Estimates and related papers for the 2022-2023 financial year to the Portfolio Committees for inquiry and report by Friday 23 December 2022.⁴
- 1.3 Following changes to the administration of the government, the hearing schedule was amended by the House on 10 August 2022 to reflect the changed ministerial responsibilities.⁵
- On 21 September 2022, the Budget Estimates resolution and schedule was further varied by the House to facilitate the postponement of the initial hearing of Portfolio Committee No. 5 Regional NSW and Stronger Communities into the Corrections portfolio, due to the unavailability of the Minister.⁶
- 1.5 The budget estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Environment and Heritage

- A hearing examining the portfolio of Environment and Heritage was held on Tuesday 23 August 2022. The following issues were raised during the committee's examination of this portfolio:
 - NSW State of the Environment report, including rates of land clearing, invasive species, and health of the wetlands
 - Increase in the number of threatened species
 - Kangaroo management programs
 - Floodplain harvesting, including water sharing plans
 - Coal ash
 - Koala populations and habitat
 - Aboriginal cultural heritage.

Local Government

- 2.2 A hearing examining the portfolio of Local Government was held on Thursday 25 August 2022. The following issues were raised during the committee's examination of this portfolio:
 - Review of the Councillor Misconduct Framework
 - Councillors' property interests and relations or connections to property developers
 - Flood recovery and assistance, including funding and grant programs for local councils in response to the 2022 Northern NSW floods
 - Amalgamation and de-amalgamation of local councils and the Local Government Boundaries Commission
 - Issues affecting animals, including the Pet Registry, Rehoming Practices Review, and pounds
 - Council rates, the rate peg and the review of the Independent Pricing and Regulatory Tribunal.

Planning, Homes

- 2.3 A hearing examining the portfolios of Planning, Homes was held on Monday 29 August 2022. The following issues were raised during the committee's examination of these portfolios:
 - Gender balance in senior leadership at the Department of Planning and Environment
 - Housing supply, including:
 - affordable, diverse and social housing
 - Departmental approaches to non-compliance with delivery
 - development consent
 - strategic planning for growth areas
 - State Environmental Planning Policies (SEPP), including the Design and Place SEPP and the Sustainable Building SEPP
 - Modelling of emissions from coal mining and development industries, in relation to NSW Government targets for emissions reduction
 - Development consent for new coal mines, including the reliance on 'reasonable and feasible' measures in approvals
 - Changes to planning controls in areas vulnerable to flooding in response to recommendations in the Report of the 2022 NSW Flood Inquiry (O'Kane and Fuller report).
