Myuna Bay Sport and Recreation Camp

1. Why did the NSW Dams Safety Committee not conduct a review of the Origin Energy report prior to the closure of the centre?

I am advised:

The Department of Communities and Justice is working with the Dams Safety Committee to facilitate an independent review to analyse the technical advice the NSW Office of Sport relied upon, when making its decision to close the Myuna Bay Sport and Recreation Centre. An initial report was published on the NSW Office of Sport website in August, and a final report is expected shortly.

2. An independent peer review was commissioned to access the technical advice relied upon for the closure of Myuna Bay Sport and Recreation Camp. Did the independent review go to the NSW Dams Safety Committee or one of its sub-committees before it was delivered to the Office of Sport?

Active Kids Rebate

The Active Kids program is designed to assist in reducing incidence of childhood overweight and obesity.

It is also recognised that participation in sport and structured physical activity has a positive impact on social and mental health outcomes for children.

50. How are these measured?

I am advised:

Program outcomes are independently evaluated by the Sprinter Research Group (Sydney University) who undertake research based on the quantitative and qualitative data generated on application and through participant surveys.

51. Does the Government measure the income bands of families that access the scheme?

I am advised:

Information is assessed on geographic location as it relates to available census data.

Providers must possess a current ABN, appropriate insurances, Working with Children clearances for those engaging in activities with children, a valid program of activity compliant with the eligibility criteria.

I am advised:

Registration and membership fees must not be increased unreasonably as a result of participation in Active Kids.

56. How does the Government ensure that clubs and organisations are not simply raising the costs of registration and membership fees?

I am advised:

The Active Kids team within the Office of Sport includes a compliance team, incorporating actuarial and investigative specialists, charged with oversighting a range of compliance functions, including allegations where an organisation may have unreasonably increased participation fees.

57. How does the Government monitor prices of registration or membership fees in activities eligible for the active kids rebate?

I am advised:

The Active Kids compliance team utilises a range of strategies to assess and ensure compliance of and by Active Kids providers.

The team also reviews historical price movements and justifications for price increases.

58. Given AusPlay reports that entry costs for junior sports can be as high as \$2,500 per child, does the Minister accept that the Active Kids rebate is doing little to help families?

I am advised:

The experience of the Active Kids team indicates participation fees for the majority of seasonal team-based sports and community-based activities registered within Active Kids range from \$60 to \$250.

The average cost of registration for team-based sports is approximately \$100.

59. Given AusPlay also indicates that only 58 per cent of children from families who earn less than \$55,000 play sport outside of school, compared to 73 per cent of children from families with an income between \$55,000 and \$174,000 and 84 per cent of children from families earning above \$174,000, isn't it fair to say Active Kids is doing little to help families encourage their kids into sport?

I am advised:

Active Kids assesses voucher take up across NSW, including an assessment of social disadvantage and mortgage stress. Areas of high social disadvantage and areas of highly ranked mortgage stress are high volume voucher locations for the program.

Active Kids assess voucher take up based on redemption.

Repairs are funded by the Department of Premier and Cabinet, Corporate and Ministerial Services.
