Question

E-Conveyancing

- 1) The Minister claims the maturity of the NSW e-conveyancing ecosystem is 'a country mile' ahead of other jurisdictions, and that other states are still catching up. Given that electronic lodgement capabilities in South Australia and Victoria are both on par with NSW, if not ahead. Victoria made e-conveyancing compulsory ahead of NSW and in many circumstances, exceptions exist where manual process are still required in NSW. Meanwhile, South Australia is approaching near 100% digital lodgement functionality.
 - (a) Can the Minister advise who came up with the enforcement-only proposal that is being considered as NSW-only legislation?
 - (b) What date was it first raised and by whom?
- 2) The concept of a national enforcement regime was first floated in the first half of 2021 within the context of industry forums that included PEXA. Industry feedback was received by the NSW ORG in response to an ARNECC Position Paper in May 2021. Given that PEXA did not withdraw from implementation working groups until December 2021 when it flagged serious concerns with a number of issues including economic viability. PEXA re-joined these forums in May 2022 ahead of, and independent of, the announcement by NSW Government to implement its own enforcement regime in July 2022.
 - (a) Are there underlying issues with implementation that aren't being resolved?
- 3) In the Government's response to Portfolio Committee No. 4 on its inquiry into the Electronic Conveyancing (Adoption of National Law) Amendment Bill 2022 (dated 10 May 2022), the Government made clear indications that "enforcement is to be the subject of a second Bill amending the ECNL scheduled for late 2022" and that "all state and territory Ministers have committed to this second Bill". No indications were given that NSW would be pioneering its own regime...
 - (a) If it was well known that NSW outpaced other states with regard to digital conveyancing, why wasn't this made clear during debates in the house?
 - (b) What changed in this short period between May and the Ministerial Forum in June 2022?

ANSWER:

- 1(a) The proposal for a NSW-specific interim enforcement regime was developed through discussions between Office of the Registrar General and Minister Dominello's Office.
- 1(b) The NSW enforcement regime proposal was raised in March 2022 in discussions between the Minister's Office and the Office of the Registrar General as a potential avenue if the national enforcement regime was delayed.
- 2(a) The interoperability reform is led by the Australian Registrars' National Electronic Conveyancing Council (ARNECC). The Office of the Registrar General continues to work with ARNECC and stakeholders to develop the detailed implementation strategy for the interoperability reform, including a detailed timetable for national rollout.

- Interoperability is a complex reform which requires input and collaboration across industry and government stakeholders. Implementation matters are being addressed proactively through existing governance and stakeholder forums.
- 3(a) The Electronic Conveyancing (Adoption of National Law) Amendment Bill 2022 was a national legislative reform to implement changes to the Electronic Conveyancing National Law (ECNL). While the ECNL is implemented in NSW as the host jurisdiction, it is a national uniform law scheme that applies in every jurisdiction, irrespective of the status of their adoption of digital conveyancing.
- 3(b) The Office of the Registrar General is working closely with ARNECC colleagues to develop the national enforcement regime. The NSW enforcement regime is an interim regime, to address delay in finalising the national regime.



The Personal Injury Commission (Commission) regularly issues communications to its stakeholders and users through the Personal Injury Commission News, its Annual Review and at its various reference groups with stakeholder cohorts regarding the nature of delays in medical assessments and the challenges faced by the Commission, primarily due to the COVID-19 related suspension of medical assessments between 2020–2022. A summary of this information is provided in <u>Personal Injury Commission News</u>, Edition 24.

The Commission's <u>Annual Review of 2020/2021</u> referred to the almost 2,000 disputes inherited from the Dispute Resolution Service awaiting assessment, and the subsequent cancellation of up to 110 appointments per week due to the first wave of the COVID-19 pandemic. Following this, there were further suspensions between June – October 2021 and in early 2022 as a result of the further waves of COVID-19 and public health orders. Alternative ways for assessments to be conducted were offered (on the papers or virtually) but the up take was small. The Commission emerged from the pandemic and re-commenced assessments from 21 February 2022, but the continuing impact of COVID-19 saw that of approximately 3,600 appointments in the Motor Accidents Division scheduled in the first six months of 2022, approximately 1,800 (50%) were unable to proceed (see <u>Personal Injury Commission News, Edition 34</u>). Further figures were published in <u>Edition 36</u> which provided detailed information about scheduled appointments in August/September 2022 (over 700 each month).

Noting this dynamic landscape relating to medical assessments, the data as to the extent of delays is only relevant to a point in time, changing regularly depending on the impact of the COVID-19 pandemic, daily filings, and the scheduling of and attendance at medical assessment appointments since the Commission's establishment.

- 85 (a) See answer to question 85.
- 86(a) The theoretical optimal standard timeframe within which a medical dispute may resolve is within 120 days, based on the Commission's Key Performance Indicators effective from 1 July 2022. These KPI's intend to quantify and monitor the Commission's performance in the 2022/2023 financial year and provide guidance to users on expected timeframes. They were developed in consultation with the Commission's stakeholders, the NSW Bar Association and the Law Society.
- 86(a)(i) See answer to 86(a).
- 86(b) The "actual current timeframe" for the resolution of a medical assessment dispute cannot be strictly quantified as each medical assessment dispute is unique, which is why the Key Performance Indicators refer to "optimal" timeframes due to the multiple variables which influence the timeline of each dispute. These include: the readiness of a matter at the lodgement stage in terms of documentation provided by the parties; the timeliness of correspondence between all parties; whether additional information is submitted while the dispute is being case managed; the volume and nature of injuries or treatments in dispute, which influences the number of medical assessments required to resolve it; the availability of Medical Assessors in frequently used specialities (orthopaedics, occupational medicine and psychiatry) to conduct medical assessments; the ability of injured people to attend scheduled appointments based on their health circumstances at the time of their scheduled appointment. Additionally, the high volume of medical assessments suspended due to the COVID-19 pandemic between 2020–2022 has not only impacted the timeframes to resolution for those specific disputes but also the portfolio of disputes lodged during and since that time. The Commission is working to

maximise the use of all appointed Medical Assessors and is currently scheduling large numbers of assessments each month to address this issue and encouraging the co-operation of its users.

86(b)i. See answer above to 86(b).

86(b)ii.

As noted at 86(a), the Commission's Key Performance Indicators provide an "optimal timeframe" of 120 days for the lifecycle of a medical dispute. It is anticipated this is unlikely to be met in high use specialities over the next 12 months in Motor Accidents matters for the reasons outlined in the answer to 86(b), although the Commission is working on a number of mitigation strategies.

86(c) – 86)(c)i. Minister to respond. Commission's comment for Minister's consideration:

86(c) 'Since its inception the PIC has helped thousands of customers resolve their disputes each year. In setting this up the PIC has simplified what was previously a complicated process for thousands customers, saving them time and giving them better access to dispute resolution'

The primary difficulty faced by the Commission is the COVID-19 pandemic which resulted in suspended assessments three times between 2020–2022 in addition to continued filings. The Commission itself has not been immune from this disease, and staff, Members and Medical Assessors have contracted the disease, or been close contacts requiring isolation, particularly during 2022. As a result, business as usual operations are impacted, and this may be considered an "internal factor".

The Commission recommenced operations at its premises at 1 Oxford Street Sydney in March 2022, gradually increasing staff and Member presence and implementing mitigation measures to address delays. This includes use of its new medical suites; recruitment of additional Medical Assessors; maximising Medical Assessor availability; and utilising opportunities to fill cancelled appointments with other claimants. The scheduling of appointments is on an upward trajectory, with August and September 2022 seeing more than 700 medical assessments scheduled each month (see Personal Injury Commission News, Edition 36).

86(c)i. The Commission has not asserted that it is operating "perfectly".

86(d) In some cases yes, the Commission is required to schedule psychiatric medical assessments beyond March/April 2023 as the currently available psychiatric medical assessments are utilised. Noting the wait time, the Commission is actively working to improve this. Where claimants are unable to attend an appointment, all efforts are made to secure a new claimant to fill this assessment appointment. Further, existing psychiatrists may provide additional availabilities between now and March/April 2023 that can be filled.

The Commission has focussed heavily on the recruitment and retention of psychiatrists. Since March 2022, the Commission has appointed a further four new Medical Assessors in the speciality of psychiatry, whose availability is being carefully managed to ensure optimal appointment scheduling.

86(d)i. and ii.

The primary reasons why injured claimants are prevented from receiving treatment is an adverse insurer's decision. This decision is then challenged in the Commission.

The delays faced in the Commission are repercussions of the COVID-19 pandemic, primarily due to the backlog of medical assessments which built up during the extended periods of suspended appointments and continued filings. The current timeframe relating to assessments of a psychiatric nature is also a reflection of the current pressure on the psychiatric profession in general resulting from the COVID-19 pandemic which has seen an increase in mental health issues in the wider community, and an increased demand for psychiatrists, thus impacting their availability to perform assessments for the Commission.

The Commission is aware of these challenges and is working on steps to mitigate them in the interests of its users. In the context of the significant disruption the pandemic caused to the Commission's operations, delays of some description were inevitable.

- 86(e) Since inception on 1 March 2021 to 31 August 2022, the Commission's turnover rate is 32.5%. This rate consists of a cohort who were made redundant as part of a restructure initiated prior to the Commission's inception, but not implemented until after its inception. Excluding the redundancies resulting from the restructure, the Commission turnover rate is 20.9%.
 - Turnover rates are calculated as the total number of exits over a time period divided by the average headcount over the same period.
- 86(f) NSW Public Service data is currently unavailable, having only recently finalised its 2021-2022 annual workforce profile.
- 86(g) Yes, a small number of Medical Assessors who were engaged by the Dispute Resolution Service and Workers Compensation Commission no longer complete medical assessments for the Commission. The Commission also elected not to re-appoint a small cohort of Medical Assessors.

86(g)i.

At the establishment of the Commission, 187 Medical Assessors were transferred from the Dispute Resolution Service and the Workers Compensation Commission for a period of one year (1 March 2021 to 28 February 2022).

Following an expression of interest and recruitment process, as at 1 March 2022, a total of 166 Medical Assessors have been appointed to the Commission for a period of three years.

The change in number of appointed Medical Assessors does not reflect the uptake of work conducted by the current Medical Assessors appointed to the Commission. Some Medical Assessors who left offered low availabilities or practised in rarely utilised specialities. They have been replaced with Medical Assessors who can offer significantly more availability. Some Medical Assessors who previously only offered medical assessments in one jurisdiction now offer assessments in both Commission Divisions.

86(g)ii.

Medical Assessors who elected not to continue were contacted by the Commission to ascertain their reasons for leaving.

86(g)iii. See answer to 86(g)ii. above.

86(g)iv.

There is no predominant reason why a Medical Assessor has decided to leave, with the following range of reasons identified:

- Retirement (age-related)
- Inability to commit to the Commission due to the busy work of their private practice
- Frustration with the Motor Accidents Portal and resulting inability to keep up with associated administrative requirements
- Not receiving enough medical assessment referrals to warrant continuing due to rare utilisation of their speciality
- Pay issues, responded to at 86(g)v.
- Unwillingness to agree to the terms and conditions and code of conduct implemented by the Commission, which differed to those in the Dispute Resolution Service

86(g)v.

Medical Assessor fee rates did not change following transition from the Dispute Resolution Service and Workers Compensation Commission to the Commission. The Commission has therefore recently commenced a process with the Statutory and Other Offices Remuneration Tribunal (SOORT) for a non-binding determination on Medical Assessor fee rates across both the Workers Compensation and Motor Accidents Divisions, and has consulted Medical Assessors throughout this process. Medical Assessors have been invited to submit their views

and/or proposals to SOORT. SOORT is expected to make a non-binding determination, which will guide the Commission as to future rates.

An issue of concern amongst Medical Assessors was the impact of a private tax ruling by the ATO which took effect from 1 September 2020, which required the existing legacy organisations and the Commission to withhold PAYG tax from the payments to the Medical Assessors (rather than payment of GST tax on top of the fees claimed). This negatively impacts fees that are actually paid.

86(g)vi. See answer to 86(g)iv.

86(g)vii.

Some doctors have expressed difficulties navigating the legacy Motor Accidents Platform acquired by the Commission from the Dispute Resolution Service. The Commission continues to provide Medical Assessors with support while this system remains in place. The Commission has also taken steps to stabilise this system pending its replacement in April 2023.

To address this, in 2021, the Commission undertook a process of discernment to identify its IT needs, committed to creating a digital tribunal, namely one where filings are by way of an online portal, meaning that Members, Medical Assessors and other decision-makers are all provided with digital briefs of the claims they are allocated. As a result, the development and implementation of a new single digital platform across both the Motor Accidents and Workers Compensation Divisions is underway. The development of this platform is part of the Commission's Strategic Priorities.

All going well, the Commission will transition from its existing platforms onto the new system from April 2023. A comprehensive plan for consultation and training of all Commission decision-makers, staff and users is expected to be undertaken in late 2022 and into early 2023. Once completed, the new single digital platform will create a seamless digital journey for injured people and all tribunal users, and a single-entry point to engage in the dispute resolution process.

The Commission's Medical Assessors have been kept abreast of the progress relating to the development of this new platform through multiple communications including the Personal Injury Commission News, Medical Assessor briefings, and the Medical Assessor Reference Group. It has been positively received by Medical Assessors.

87) Minister to respond. Commission's comment for Minister's consideration:

90 and 90(a)

The number of Medical Assessors alone is not determinative to meet a demand of medical assessments. What is determinative is the amount of availability that a Medical Assessor provides to the Commission. A smaller group with larger availability is far preferrable to a larger

group who offers little availability, and decision makers become more skilled and efficient the more assessments they undertake. The demand at present is a combination of new filings and matters on hand. Matters on hand are significantly larger due to the pandemic disruption. Consequently the current demand in terms of new filings and matters on hand is an historical anomaly due to the pandemic.

Presently, the Commission has enough Medical Assessors (163 as of 9 September 2022) to meet the number of medical assessments required for disputes lodged on a monthly basis.

It is the existing number of matters on hand which is significantly higher as a repercussion of the COVID-19 backlog (suspended assessments between 2020–2022) which impacts this demand. During that time, filings continued, and there has been an increase in disputes requiring assessment (particularly psychiatric assessments). The pressures faced by the Commission to meet the demand of psychiatric assessments is widely experienced in the community as it reflects the prevalence of mental health issues arising from the COVID-19 pandemic.

To address this, the Commission is methodically and logically working through the matters on hand, making inroads by maximising utilisation of Medical Assessors and availabilities, moving assessments online, and implementing a recruitment and retention strategy for Medical Assessors in high use specialities, having retained four new psychiatrists during 2022.

The Commission has met with the Chair of the NSW Branch Committee of the Royal Australian and New Zealand College of Psychiatry to discuss the recruitment of further Medical Assessors. The Commission has also written to the Royal Australasian College of Surgeons and Australasian Faculty of Occupational & Environmental Medicine to increase the number of assessors in these high utilisation specialties.

91, 91(a) Minister to respond. Commission's comment for Minister's consideration:

- 91) The Commission was opened on 1 March 2021. It is not yet working at maximum efficiency simply because it is still in an early phase of its lifecycle, and its operations during this time were heavily impacted by the COVID-19 pandemic. The President has briefed the Minister on the various projects which are on track to see the Commission operate at maximum efficiency as a modern tribunal, including the completion of the renovation of the 1 Oxford Street premises with technological enhancements in hearing rooms to conduct virtual hearings, new medical suites, the creation of a single digital platform across both the Motor Accidents and Workers Compensation Divisions, the creation of Key Performance Indicators from 1 July 2022, and the Commission's Strategic Plan. The Commission continues to work diligently against these projects to streamline and enhance its operations.
- **91(a)** It is not the minister's function to interfere in the running of an independent statutory tribunal. See 91 as to what is being done at the Commission.
- 92) To state that CARS Assessors would determine a damages assessment within three weeks is incorrect. The *Motor Accident Injuries Act 2017* required a CARS Assessor to issue a certificate and statement of reasons as soon as practicable (preferably within 21 days of the assessment). Prior to this stage, it was practice amongst CARS Assessors to undertake frequent directions hearings for readiness, thus being months before a damages assessment took place. There are many factors as to why some assessments, due to complexity, took longer. The 21-day timeframe for the issuing of decisions was also impacted by the complexity of a matter, illness or leave of a CARS Assessor. In some cases, CARS Assessors were actively managed to address delays.

These factors applicable to CARS Assessors continue in matters being heard by Motor Accidents Members of the Commission, with the additional impact of COVID-19 infection which has been prevalent.

93) The majority of Motor Accidents Members issue a damages assessment decision within 28 days of the hearing of an assessment concluding <u>or</u> evidence closing. Some complex assessments can take longer and parties are kept informed. The Commission is managing a very small cohort of

Members (less than 3) whose timeliness is currently not of the standard required by the Commission.

94, 94(a)-(b) Minister to respond. Commission's comment for Minister's consideration:

- 94) The vast majority of Commission Members in the Motor Accidents Division produce their decisions within 28 days of a hearing (see answer to 93). There is a small number (less than 3) who do not meet the appropriate timeframe and who are being actively managed. Delays are not an issue with the Commission's Workers Compensation Members.
- **94(a)** Given that the Commission has 56 Members, it is unsurprising that in a group of that size, some require support to meet performance requirements and to improve those to an acceptable standard.
- **94(b)** This is not the Minister's role with respect to an independent statutory tribunal. In any event, the delays referred to are limited to a small cohort of Members who are being actively managed.
- Minister to respond. Commission's comment for Minister's consideration:

 This is a question for the Attorney General, being the relevant Minister responsible for the appointment of Members. Under the *Personal Injury Commission Act 2020* the President has the power to advise the Attorney General about the removal of Members and has not made any request for removal of any Member. As stated above in answer to q 94 a small number of Members are being actively managed to improve timeliness.

The PIC-Federal Jurisdictions

- 96) On what basis did the PIC dismiss claims for medical or damages assessments between residents of one State and a private corporation in another State?
 - (a) How did the PIC come to the view that these claims involved federal jurisdiction?
- 97) How many claims did the PIC incorrectly dismiss by falsely asserting federal jurisdiction?
- 98) With the District Court having made clear that no federal jurisdiction arose, of the cases that were incorrectly dismissed, what has the PIC done to now expedite determination of those cases?
- 99) Is the Minister aware that the PIC President has commenced sitting as a District Court judge in addition to undertaking his PIC Presidential duties?
 - (a) Was it part of the government's design for the PIC that the PIC President would sit as a District Court judge (DCJ), independent of his PIC duties?
 - (b) Is the Minister of the view that the role of the PIC President is a fulltime job?
 - (c) If it is, then how does the President have the spare time to sit as a DCJ?
 - (d) Is the Minister aware that the President of the PIC is sitting as a DCJ to rule on PIC related issues?
 - (e) Does the Minister see any conflict of interest between the President of the PIC sitting as a DCJ to rule on PIC related issues, given that this is him sitting in judgment on his own organisation's decisions?
 - (f) Is the Minister aware that an application was made to the President of the PIC sitting as a DCJ to disqualify himself in relation to PIC related matters and that the President (sitting as DCJ) has refused to do so?

(g) What view does the government take as to the conflicts of interest involved?


ANSWER:

- The Commission relied on Division 3.2 of the *Personal Injury Commission Act 2020* which sets out the process for matters potentially involving the exercise of federal jurisdiction. Only a court of the State, identified as the District Court in Division 3.2, can exercise federal jurisdiction. The Court of Appeal provided guiding precedent on this issue in *Attorney General for New South Wales v Gatsby* [2018] NSWCA 254, stipulating that it is not for a tribunal to decide the "metes and bounds" of its own jurisdiction. Accordingly, matters identified by the Commission to be *potentially* impacted by federal jurisdiction were dismissed so parties could make appropriate applications to the District Court for a decision on federal jurisdiction in accordance with Div 3.2 of the *Personal Injury Commission Act 2020*. The parties do not have to wait for the Commission to act, if they think the matter is potentially affected by federal jurisdiction, they can approach the District Court themselves. The Commission provided lengthy educational material for parties regarding federal jurisdiction through its website and newsletters to help them navigate the issue and clearly understand the action they needed to take.
- 96(a) The Commission did not form the "view" that these claims involved federal jurisdiction. This is a matter for the District Court (see answer to 96). The Commission dismissed claims it was of the opinion would *potentially* involve the exercise of federal jurisdiction.
- 97) None. The Commission did not incorrectly dismiss any claims, or "falsely" assert any claims were impacted by federal jurisdiction. As answered at 96, the determination of whether or not a matter is impacted by federal jurisdiction is a matter for the District Court to decide.
- As answered at 97, the Commission did not incorrectly dismiss any matters. Where matters were dismissed by the Commission and it has been subsequently determined by the District Court there was a basis for the Commission to hear those matters, the Commission has expedited determination of those matters and allowed those matters to retain original filing dates at the Commission. This process is set out in the Commission's website at: https://pi.nsw.gov.au/what-is-federal-jurisdiction-and-and-how-does-it-affect-applications.

99, 99(a) – (g) Minister to respond. Commission's comment for Minister's consideration:

- **99)** The Minister would be aware. The President wrote to the Minister and has been in consultation with his office regarding this.
- 99(a) The impact of the federal diversity jurisdiction upon Commission operations in the Motor Accidents Division has been a matter of concern amongst users and stakeholders of the Commission. Following briefing, it was agreed that this issue would be assisted by the President, who is also a District Court judge, hearing a discrete number of matters with respect to this particular issue. The Commission's stakeholders, including the NSW Bar Association and Law Society were consulted about this proposal, and supported it.
- **99(b)** The Commission President's role is fulltime.
- **99(c)** The manner in which the President carries out his functions is not a matter for the Minister. The President carries a heavy workload, like the rest of the judiciary, and is adequately supported to ensure he meets his duties at the Commission. The Minister supported the President determining a discrete number of federally impacted matters in order to bring certainty to this area of the law.
- **99(d)** The issues which are heard and determined by District Court judges would not be a matter for the Minister. When sitting in the District Court, the issue being determined by His Honour is federal jurisdiction, and not rulings on "Commission Related issues".
- **99(e)** There is no conflict. See answer to 99(d) and the judgment in *Worldon v Transport Accident Commission of Victoria & ors* [2022] NSWDC 378 (9 August 2022) which rejected an assertion that the President was "sitting in judgment on his own organisation's decisions".

- 99(f) This application was determined and refused in the decision of *Worldon v Transport Accident Commission of Victoria & ors* [2022] NSWDC 378, which was published on NSW caselaw on 9 August 2022. The decision sets out his Honour's reasons and it would not be the Minister's role to intervene in the determination of such matters in the District Court. The decision has not been appealed and the other parties present in this matter did not support the application.
- 99(g) There is no conflict of interest involved. The issue of the asserted conflict of interest has been determined by judgement in Worldon v Transport Accident Commission of Victoria & ors [2022] NSWDC 378

McDougall Review Recommendation 34

- 104) What consultation has occurred so far with stakeholder groups with regards to reforming the Workers Compensation system?
 - (a) Who has been involved with this consultation?
- 105) What stakeholders were informed of SIRA's decision that the "consolidation of the legislation has been flagged as not a particularly great idea and it's one where we might more try to start again with a fresh bill" as Mr Dent stated in Budget Estimates on 30 August 2022.
 - (a) In relation to Mr Dent's statement that "that work has already started. the team has been recruited to start the process of redrafting", who is in this team?
 - (b) Given Mr Dent has stated that starting again with a fresh bill, why is SIRA still focusing on "a couple of tranches of work ...on some of those key benefits issues that were raised in McDougall early. The SIRA board and I have discussed that our view would be, rather than to try and tackle everything holistically, there would be some merit in at least doing that work around benefits first". What benefits is Mr Dent referring to in this statement?
- 106) Given McDougall's Recommendation 34 stated that the Government should "appointing a suitable agency or body to conduct a review and reconciliation of the Workers Compensation Act 1987, Workplace Injury Management and Workers Compensation Act 1998 and State Insurance and Care Governance Act 2015 into a single consolidated piece of legislation...", has the Government decided that SIRA will be undertaking this work?

ANSWER:

104) This is a major, multi-year legislative reform project that commenced with public consultation in late 2021 and early 2022 on major scheme elements that were the subject of recommendations

- from the McDougall review. Further public consultation, including with key stakeholders, is not expected to occur until mid-2023.
- 105) There has been no decision by SIRA. SIRA engaged with NSW Parliamentary Counsel's Office (PCO) on a preliminary basis in relation to recommendation 34. PCO has provided a view, based on previous similar major legislative exercises, that it is better to start from first principles in the process of drafting a Bill.
- (a) A small internal team within SIRA has been established to commence the preparatory work. This preparatory work will inform decision-making around an overall approach to the recommendations. Given this is a major, multi-year project, the project will expand in the future to include appropriate expertise and structures around governance and workstreams, and to ensure appropriate engagement with stakeholders.
- (b) There are some specific recommendations made by McDougall that may be able to be addressed more quickly than others. SIRA has responded to recommendation 40 (settlement of lump sum death benefits) and that amendment has been included in the State Insurance and Care Legislation Amendment Bill 2022, which remains before Parliament. SIRA is undertaking further consultation with stakeholders in 2022 on expanding access to commutations in the scheme. With respect to remaining benefit related recommendations (37-39), SIRA will seek to engage with stakeholders to ascertain the viability of these being addressed while the major rewrite of the legislation is being undertaken.
- 106) SIRA has commenced preparatory work to inform decision-making including around resource requirements and an overall approach to recommendation 34. These matters, including SIRA's role in this process will be matters for consideration by Government.

Parkes Project work and reforming Workers Compensation

107) The Law Society has stated in its submission to the Law and Justice Committee Review of the 2022 Workers Compensation scheme that "we strongly support a review that builds on the work of the Parkes Project, and looks at the scheme as a whole, rather than the current piecemeal approach to amendment". Will the Minister be revisiting this work?

ANSWER:

107) SIRA notes that the Parkes Project was not able to complete a report on its work, as observed by the Hon. Robert McDougall. The project considered matters that are now effectively subsumed by recommendation 34 of the McDougall review. Some issues raised in the Parkes Project (such as reforms relating to dispute resolution) have since been addressed by legislative reform, and other work for recommendation 34 of the McDougall review will draw from work undertaken in the Parkes review where possible and appropriate.

Consultants

- 108) Has SIRA used any consultants to work on Workers Compensation legislation?
 - (a) If so, who?
 - (b) How much has this cost for the last two financial years?
- 109) What consultants have been engaged by SIRA and for what work for the last two years?

ANSWER:

108) (a) Ernst & Young has provided advice to SIRA on the estimated impact and cost of a number of potential legislative amendments over the past two years.

108 (b) and 109)

Delays for psychological assessments

- 110) In terms of delays to obtaining psychological assessments in the workers compensation system and the Personal Injury Commission, why is SIRA as the regulator not taking responsibility for enforcing timeframes so that delays to treatment aren't commonplace?
 - (a) Why aren't these delays taken off the claims time limits?

ANSWER:

110) The Personal Injury Commission is an independent statutory tribunal within the New South Wales justice system, and as such it is not regulated by SIRA.

Unscrupulous medical assessors for Workers Compensation claims

111) What is SIRA doing to ensure that doctors whose reviews are routinely challenged by PIC assessors are disallowed from undertaking workers compensation assessments?

ANSWER:

111) Recent amendments to the State Insurance Care and Governance Act 2015 allow SIRA to direct a relevant service provider to not provide specified or any relevant services.

SIRA is currently drafting the regulation and guidelines to support implementation of these amendments, including the definition of "relevant service" and will shortly be consulting on these drafts.

As part of drafting, consideration will be given to including the services provided by medical assessors in the definition of "relevant services".

Further consideration would then need to be given to whether routine challenges from PIC assessors should be a circumstance in which a direction to not provide services would be issued.

Personal Injury Commission (PIC) delays for medical assessments

- 112) As the Personal Injury Commission newsletters acknowledge that there is delay in medical assessments, when will data be published about how many cases are currently delayed or the extent of the delay?
- Claimants in the PIC are waiting upwards of twelve months to have a treatment dispute assessed. As early intervention is critical for psychological claims, what is the Government doing to ensure these delays are rectified?

ANSWER:

112) The data which is published is a matter for the Commission as an independent statutory tribunal. The Commission has made, and continues to make, a great deal of information publicly available in its publications, including the Personal Injury Commission News and the Annual Review. The Commission encourages a close reading of those publications.

113) Minister to respond. Commission's comment for Minister's consideration:

The aspect of early intervention for treatment of psychological injuries is primarily a matter that must be directed to insurers who have elected to dispute psychological injury claims at the outset. It should be noted that a Commission Medical Assessor's role is not to provide treatment, but to determine the dispute.

All efforts are made by the Commission to alleviate the delays, particularly in psychiatric assessments. This involves maximising utilisation of Medical Assessors and availabilities, moving assessments online, utilising cancelled appointments, and implementing a recruitment and retention strategy of Medical Assessors. During the several Sydney lockdowns when the Commission was required to suspend medical assessments, the Commission offered options to resolve these matters on the papers or through consent mediations, but the uptake rate was very low.

Currently, a number of amendments to the *Personal Injury Commission Act 2020* are on their way to Parliament, one of which is to provide the Commission with the power to allocate Motor Accidents matters for early dispute resolution through mediation. This intends to target the high number of medical treatment disputes. If this provision becomes operative, the Commission will allocate mediators to attempt to resolve these disputes, providing parties with an avenue to engage in good faith negotiation as they await assessments.

Consultations are also taking place with CTP insurers regarding the high incidence of refusal to fund medical treatment and steps that might be taken to bring these matters to an early resolution.

Exemptions for WHS Regulations

114) What work has SIRA undertaken to examine the link between the current 11 exemptions to Work Health and Safety regulations and increased workers compensation claims?

ANSWER:

114) The Work Health and Safety Regulation 2017 (the Regulation) has a general power (clause 684) which allows SafeWork NSW to grant an exemption from compliance with any provision of the Regulation. Safework NSW may also issue Exemptions under the Explosives Regulation 2013 (clause 112) and the Dangerous Goods (Road and Rail) Regulation 2014 (clause 164).

In deciding whether or not to grant an exemption under clause 684 the regulator (SafeWork NSW) must have regard to a number of relevant matters, including whether the granting of the exemption will result in a standard of health and safety at the relevant workplace that is at least equivalent to the standard that would be achieved by compliance with the relevant legislative provision.

Currently Safework NSW has 8 exemptions to the WHS Regulation (2017) outlined on its website:

Material containing Chromium (III) compounds at no more than 0.8% used for abrasive blasting

General diving work – qualifications

Audiometric testing requirements

Common areas used only for residential purposes where no workers or contractors are engaged Ensuring hazardous chemicals are correctly labelled

Ensuring hazardous chemicals are correctly labelled – containers

Packaging of Category A medical waste for road transport

University students and volunteer divers undertaking research or education in marine sciences

SIRA has not examined the link between these exemptions and increased workers compensation claims.

Summary

NSW Health Check - Interoperability Implementation Program Report

Purpose

This document is a summary of the independent NSW health check of the interoperability implementation program undertaken on behalf of the NSW government and administered by the Department of Customer Service. The project sponsor was the NSW Registrar General.

The stakeholders interviewed as part of the health check during May 2022 included NSW Land Registry Services, the Australian Institute of Conveyancers (NSW), the NSW Law Society, the Australian Banking Association, financial institutions, and NSW government. An initial report with recommendations was prepared on the basis of these interviews. Electronic Lodgment Network Operators (**ELNO**) were interviewed in a second stage, in June 2022. The final report is dated 8 August 2022.

Scope of the review

NSW Office of the Registrar General (**ORG**) is implementing ongoing and independent health checks to review the risks and status of the national roll-out of interoperability. The health checks will be used to inform Ministers and the Australian Registrars' National Electronic Conveyancing Council (**ARNECC**), and may be used to inform industry, and guide ongoing decision-making. This is the first of a series of ongoing health checks.

The focus areas for health checks are intended to be:

- **Risk Management** time, quality, technology, data privacy cyber security, reputation, business continuity and quality of business services.
- Industry system readiness A high level review of ELNO system readiness to meet the implementation dates for interoperability, and technical due diligence more generally regarding ELNOs, Land Registries, State Revenue Offices, and financial institutions.
- Governance Consideration of project governance (roles and responsibilities to deliver the project, resource allocation, time management and process management) and stakeholder governance
- Stakeholder Management Consideration of the stakeholders that may contribute to or be affected by new ICT environments and capabilities, including end-users (lawyers, conveyancers and financial institutions), government staff, private sector operators of land registries (where applicable), citizens and technology providers.
- Change Management Consideration of how the change will affect stakeholders, expected acceptance or resistance and actions required to move to new ways of working.
- Readiness assessment an independent assessment of readiness:
 - readiness of participating parties to operate collaboratively in order to successfully lodge property transactions (interoperate).
 - interoperable transactions (or types of interoperable transactions) must not be permitted until confirmation that:

- transactions can be completed securely and in a timely manner; and
- systems are in place to respond and remediate any failing transactions or impacts on consumers, users or ELNOs.

This health check focused on confirming the proposed approach is the best value for money option to achieve the intended outcomes:

- Delivery strategy, plans and mechanisms are robust, realistic, appropriate and manageable
- The project is clearly understood and supported by users and stakeholders, and stakeholder, change management and communications plans are adequate
- Appropriate and effective governance is in place for leading, managing and monitoring the project (or individual projects of a program)
- Major risks and issues are identified, and management plans developed
- The scope and requirements specifications are realistic and unambiguous
- · Whether the scale, outcomes, timescales and impact of external issues are considered
- Financing for government expenditure has been adequately assessed for the project and that it
 has a realistic, properly resourced and authorised plan through to the next stage
- · Planning assumptions, and whether the project teams can deliver the next stage; and
- Quality plans for the project and its deliverables.

For the avoidance of doubt, the health check did not consider the merits of the government's policy of introducing a competitive market for electronic lodgement network operators nor the legislation to enable this policy.

Report recommendations and ORG response

The report made recommendations about:

- Defining three distinct phases to the program: legislative, implementation, ongoing operations, and considering the future operations phase, as part of the implementation phase.
- Engaging Cyber NSW in the program.
- Further work on the schedule for the program.
- Establishing a steering committee to report to ARNECC, responsible for program implementation governance.
- Engaging the following expertise: technical architect; and change management / communications to design and facilitate ongoing communication with stakeholders.

ORG supports these recommendations and has commenced implementation.

The report also recommended engagement of a commercial management expert, which ORG is considering further.

Next assurance review

The Review Team recommend that health checks be conducted approximately every 6 months to align with key project events or milestones. The times should be confirmed once the program schedule is revised, suggested triggers for a review are listed below.

Suggested time of future health checks:

- May 2022 initial review (this Review)
- TBD readiness for Day-1 transaction

- TBD readiness for Day-2 industry-wide testing
- TBD readiness for IOP rollout
