Notes and costing assumptions

The policy proposes to allocate \$155 million (including \$116 million over the forward estimates) for various programs to address violence against women in NSW. A summary of the various programs and allocations is shown in the table below and overleaf.

The PBO estimates that the cost of the policy is \$116.4 million over the forward estimates and \$155 million by 2022-23.

Notes and costing assumptions continued:

The policy states that the following components of the plan would have nil budget impact. These components would be part of Departments' operations and their cost absorbed by existing agency resources:

- Make the Department of Premier and Cabinet responsible for domestic, family and sexual violence in NSW
- Deliver an annual domestic, family and sexual violence budget and accountability statement
- Have the Premier deliver an annual statement on the Government's progress during 16 Days of Activism to Eliminate Violence Against Women
- Establish an expert committee to review responses to domestic, family and sexual violence across NSW, in its first term
- Establish an Aboriginal and Torres Strait Islander Women's Advisory Group
- Deliver age-appropriate school-based strategies and develop Respectful Relationships Education
- Review existing perpetrator behaviour change interventions.
